RESOLUTION PLACING NAMES OF  
CANDIDATES ON BALLOT FOR AMELIA  
ISLAND MOSQUITO CONTROL DISTRICT  
ELECTION TO BE HELD NOVEMBER 3,  
1970.

WHEREAS, Chapter 388, Florida Statutes, requires the Board of County Commissioners of Nassau County, Florida, to hold a special election at the same time of the general election to be held in 1970 for the election of three (3) members of the Board of Commissioners of the Amelia Island Mosquito Control District, and

WHEREAS, under and by virtue of said law, it is the duty of said Board of County Commissioners to be caused to be placed upon the ballot for such election the names of any qualified persons as candidates for the office of Members of the Board of Commissioners of the Amelia Island Mosquito Control District, which names shall have been presented to said Board of County Commissioners by petition signed by not less than twenty-five (25) qualified electors for said election and filed with said Board of County Commissioners not less than thirty (30) days before said election, and

WHEREAS, petitions have been filed with this Board, each duly signed by more than twenty-five (25) qualified electors of Nassau County, residing in said Mosquito Control District, stating that persons named in said petitions are qualified persons as candidates for the office of Member of the Board of Commissioners of said Mosquito Control District, which names should be placed on the ballot for said election, the following persons being named on said petition, to-wit:

WHEREAS, the Supervisor of Registration of Nassau County, Florida, has certified to this Board that at least twenty-five (25) persons who signed each of said petitions are qualified electors in said Mosquito Control District, and

WHEREAS, the said Board of County Commissioners has determined that each of the above named persons are qualified to hold the office of Member of the Board of Commissioners of said Mosquito Control District and that said petitions are proper and sufficient to have such names placed on the ballot of said election all in accordance with Chapter 388, Florida Statutes.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, in special meeting duly assembled, that the petitions heretofore filed with this Board as set forth in the preamble hereto be, and the same are, hereby accepted and approved as being in conformity with the requirements of Chapter 388, Florida Statutes.

BE IT FURTHER RESOLVED that the County Attorney be, and he is, hereby authorized and directed to prepare the necessary voting machine ballot for the holding of said election in said Mosquito Control District, comprising Precincts Number 1, 2, 3, 4 and 5, with the use of voting machines, and that the following names be placed upon said ballot in the following order, to-wit:
