

RESOLUTION NO. 80

**RESOLUTION CHANGING POLLING PLACE
FOR PRECINCT NUMBERED 11 IN NASSAU
COUNTY, FLORIDA.**

WHEREAS, the polling place for Precinct Numbered 11 in Nassau County, Florida, for many years has been located at the Health Clinic in the Brandies Building in the Town of Callahan, Nassau County, Florida, and

WHEREAS, the use of said Health Clinic in the Brandies Building is no longer adequate for the purpose of holding elections in said Precinct, and

WHEREAS, this Board has determined that the Nassau County Health Center in Callahan on Mickler Street, fronting on the Seaboard Coastline Railroad Right of Way and which property is described as follows:

All that certain lot, piece or parcel of land, situate, lying and being in the Town of Callahan, County of Nassau and State of Florida, and more particularly described by metes and bounds as follows:

"Property being known as the "Gerald Lot" bounded on the West by Right of Way of the Waycross Railroad, now known as the Atlantic Coast Line Railroad, Two Hundred and Ten feet (210); thence running East Three Hundred and Twelve (312) Feet; thence running North Two Hundred and Ten (210) Feet; thence running West Three Hundred and Twelve (312) Feet to the (Waycross Railroad) Atlantic Coast Line Railroad, the place of beginning. Containing one and one-half (1½) acres, more or less. Also known as Lot One (1) in Callahan.

Being the same or identical property as described in that certain Warranty Deed, dated May 12, 1969, and recorded in Official Records Book 93 at Page 582 of the Public Records of Nassau County, Florida.

WHEREAS, this Board feels that it is in the best interest of the electors of said Precinct Numbered 11 in Nassau County, Florida, that the polling place for said Precinct be established at said Health Center Building for the purpose of holding all future elections.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, in regular meeting duly assembled, that the polling place for Precinct Numbered 11 in Nassau County, Florida, be, and the same is hereby designated and established in that certain building known as the Health Center in the Town of Callahan, Nassau County, Florida, and more fully described in the preamble hereto, and that all future elections, special, primary and general, shall be held in said building for said Precinct Numbered 11.

BE IT FURTHER RESOLVED that the Clerk of this Board is hereby directed to publish for four consecutive times in the Nassau County Record, a newspaper of general circulation in Nassau County, Florida, a notice substantially as follows:
