RESOLUTION OF BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, DESIGNATING AND ESTABLISHING ELECTION DISTRICTS OR PRECINCTS; CREATING CERTAIN NEW ELECTION DISTRICTS OR PRECINCTS; CONSOLIDATING CERTAIN EXISTING ELECTION DISTRICTS OR PRECINCTS; RE-NUMBERING ELECTION DISTRICTS OR PRECINCTS AND DESIGNATING AND ESTABLISHING VOTING PLACES IN EACH ELECTION DISTRICT OR PRECINCT IN NASSAU COUNTY, FLORIDA.

WHEREAS, this Board has determined that certain precincts as now existing require their boundaries to be extended, and other precincts require their boundaries to be contracted, so that the number of voters can be distributed among the election districts and that certain precincts should be consolidated in the less populous areas, and

WHEREAS, this Board has determined that the boundaries for each election district or precinct in Nassau County, should be set forth in this resolution and re-numbered, and that a polling place should be designated and established for each election district or precinct in Nassau County, Florida, and

WHEREAS, this Board feels the requirements of <u>Fla</u>.

<u>Stat</u>. § 101.73(1973) could more fittingly be complied with by a new scheme of election districts and precincts.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Nassau County, Florida, in a special meeting duly assembled on this 26th day of february 1974, that the election districts or precincts for Nassau County, Florida, as re-numbered herein together with their respective polling places be, and they are, hereby designated and established as follows:

Election District or Precinct No. 1

Beginning at the point where Egans Creek meets the low water mark of the Amelia River, thence proceed in a Southerly direction along the low water mark of the Amelia River and continue along a prolongation of the center line of Fourth (4th) Street to its intersection with the center line of Beech Street, thence in an Easterly direction along the center line of Beech Street to its intersection with the center line of Eighteenth (18th) Street, thence in a Northerly direction along the center line of Eighteenth (18th) Street to its intersection with the center line of Atlantic Avenue, thence in an Easterly direction along the center line of Atlantic Avenue to its intersection with the center line of Eighteenth (18th) Street, thence in a Northerly direction along the center line of Eighteenth (18th) Street and continue along a prolongation of the center lines of Stanley Drive and Fifteenth (15th) Street to the intersection with Egans Creek, thence in a Westerly direction along the meanderings of Egans Creek to the Amelia River and point of beginning. The polling place for said Precinct One (1) is hereby designated and established at the American Legion Home located at the corner of Atlantic Avenue and Eleventh Street, in the City of Fernandina Beach, Nassau County Florida.

Election District or Precinct No. 2

Beginning at the point where Egans Creek meets the low water mark of the Amelia River, thence proceed in a Northerly direction along the low water mark of Amelia River and continue in a Northerly and Easterly direction along the low water mark of the Cumberland Sound and around the North end of Amelia Island to the intersection with the low water mark of the Atlantic Ocean, thence in a Southerly direction along the low water mark of the Atlantic Ocean to its intersection with a prolongation of the center line of Simmons Road,

thence in a Westerly direction along a prolongation of the center line of Simmons Road to its intersection with the City limits of Fernandina Beach, Florida, thence in a Northerly direction along the city limits of Fernandina Beach and continue along the meanderings of Egans Creek to its intersection with the prolongation of the center line of Beech Street, thence in a Westerly direction along the prolongation of the center line of Beech Street to its intersection with the center line of Eighteenth (18th) Street, thence in a Northerly direction along the center line of Eighteenth (18th) Street to its intersection with the center line of Atlantic Avenue, thence in an Easterly direction along the center line of Atlantic Avenue to its intersection with the center line of Eighteenth (18th) Street, thence in a Northerly direction along the center line of Eighteenth (18th) Street and continue along a prolongation of the center lines of Stanley Drive and Fifteenth (15th) Street to the intersection with Egans Creek, thence in a Westerly direction along the meanderings of Egans Creek to the Amelia River and point of beginning. The polling place for said Precinct Two (2) is hereby designated and established at the Municipal Auditorium located at the Recreation Center on Atlantic Avenue of the City of Fernandina Beach, Nassau County, Florida.

Election District or Precinct No. 3

Beginning at the point where the prolongation of the center line of Fourth (4th) Street intersects with the low water mark of the Amelia River, thence proceed in a Southerly direction along the low water mark of the Amelia River to its intersection with a prolongation of the center line of Indigo Street, thence in an Easterly direction along a prolongation of the center line of Indigo Street to its intersection with the center line of Sixth (6th) Street, thence in a Southerly direction along the center line of Sixth (6th) Street

to its intersection with the center line of Jasmine Street, thence in an Easterly direction along a prolongation of the center line of Jasmine Street to its intersection with Egans Creek, thence in a Northerly direction along the meanderings of Egans Creek to its intersection with a prolongation of the center line of Beech Street, thence in a Westerly direction along a prolongation of the center line of Beech Street to its intersection with the center line of Fourth (4th) Street, thence in a Northerly direction along a prolongation of the center line of Fourth (4th) Street to the Amelia River and point of beginning. The polling place for said Precinct Three (3) is hereby designated and established at the City Hall of Fernandina Beach, Nassau County, Florida, located at the Corner of Second (2nd) and Ash Street, in said City.

Election District or Precinct No. 4

Beginning at the point where the prolongation of the center line of Indigo Street intersects with the low water mark of the Amelia River, thence proceed in a Southerly direction along the low water mark of the Amelia River to its intersection with a prolongation of the center line of Simmons Road, thence in an Easterly direction along a prolongation of the center line of Simmons Road to its intersection with the city limits of Fernandina Beach, Florida, thence in a Northerly direction along the city limits of Fernandina Beach and continue along the meanderings of Egans Creek to its intersection with a prolongation of the center line of Jasmine Street, thence in a Westerly direction along a prolongation of the center line of Jasmine Street to the intersection with the center line of Sixth (6th) Street, thence in a Northerly direction along the center line of Sixth (6th) Street to the intersection with the center line of Indigo Street, thence a Westerly direction along a prolongation of the center line of Indigo Street to the Amelia River and point of beginning. The polling place

for said Precinct Four (4) is hereby designated and established at the County owned Building located at Five Points, being located at the Northwest corner of the intersection of State Road No. 200 and the County Road commonly called "Dairy Road", in Nassau County, Florida.

Election District or Precinct No. 5

Beginning at the point where a prolongation of the center line of Simmons Road intersects with the low water mark of the Amelia River, thence proceed in a Southerly direction along the low water mark of the Amelia River and continue along the low water mark of the South Amelia River to the intersection with the Nassau Sound at the South end of Amelia Island, thence along the low water mark of the Nassau Sound and around the Southerly end of Amelia Island and continue Northerly along the low water mark of the Atlantic Ocean to its intersection with a prolongation of the center line of Simmons Road, thence in a Westerly direction along the prolongation of the center line of Simmons Road to the low water of the Amelia River and point of beginning. The polling place for said Precinct No. Five (5) is hereby designated and established at the Kraft Athletic Club Building (commonly known as "Ten Acres") being located at a point on Amelia Road near the intersection of the same with Phillips Manor Road, in the Community of Amelia, Nassau County, Florida.

Election District or Precinct No. 6

Beginning at the point of intersection of the South Amelia River with the Nassau River, thence proceed in a Westerly direction along the meanderings of said Nassau River to its intersection with Lofton Creek, thence run in a Northerly direction along the meanderings of Lofton Creek to its intersection with the Northwestern boundary of Section Fifty-one (51) Township Three (3) North Range Twenty-seven (27) East, thence in a Northeasterly direction along

the Northwestern boundary of said Section Fifty-one (51) to the Southeastern boundary of Section Thirty-eight (38) Township Three (3) North Range Twenty-seven (27) East; thence proceed in a Northeasterly direction along the Southeastern boundary of said Section Thirty-eight (38) to its intersection with the Range line between Range Twenty-seven (27) East and Range Twenty-eight (28) East, thence run in a Northerly direction along said Range line to its intersection with the low water mark of the St. Marys River, thence in an Easterly direction along the low water mark of the St. Marys River to its intersection with the low water mark of Cumberland Sound, thence in a Southerly and Easterly direction along the low water mark of the Cumberland Sound to the intersection with the low water mark of the Amelia River, thence run in a Southerly direction along the low water mark of the Amelia River and continue along the low water mark of the South Amelia River to the low water mark of the Nassau River and point of beginning. place for Precinct No. Six (6) is hereby designated and established at the County owned building located North of the Intersection of State Road No. Two Hundred (200) and Nassauville Road on a prolongation of the Nassauville Road (SR No. S-107), in the Community of O'Neil, Nassau County, Florida.

Election District or Precinct No. 7

Beginning at the point of intersection between the Nassau River and Lofton Creek, thence proceed in a Northerly direction along the meanderings of Lofton Creek to its intersection with the Northwestern boundary of Section Fifty-one (51) Township Three (3) North Range Twenty-seven (27) East, thence run in a Northeasterly direction along the Northwestern boundary of said Section Fifty-one (51) to the Southeastern boundary of Section Thirty-eight (38) Township Three (3) North Range Twenty-seven East, thence run in a

Northeasterly direction along the Southeastern boundary of said Section Thirty-eight (38) to an intersection with the range line between Range Twenty-seven (27) East and Range Twenty-eight (28) East, thence run in a Northerly direction along said Range line to its intersection with the low water mark of the St. Marys River, thence in a Westerly direction along the low water mark of the St. Marys River to its intersection with the prolongation of the center line of Interstate Highway No. Ninety-five (95) (this is at the approximate point where the Range line between Range Twentysix (26) East and Range Twenty-seven (27) East intersects the low water mark of the St. Marys River), thence in a Southerly direction along the prolongation of the center line of Interstate Highway No. Ninety-five (95) to its intersection with the low water mark of the Nassau River, thence in a Southerly and Easterly direction along the low water mark of the Nassau River to Lofton Creek and point of beginning. The polling place for said Precinct No. Seven (7) is hereby designated and established at the County owned Building located at the intersection of State Road Two-Hundred (200) and Dairy Road, in the Town of Yulee, Nassau County, Florida.

Election District or Precinct No. 8

Beginning at the point where a prolongation of the center
line of Interstate Highway No. Ninety-five (95) intersects with
low water mark of the St. Marys River, thence proceed in a Southerly
direction along the prolongation of the center line of Interstate
Highway No. Ninety-five (95) to its intersection with the Southern
boundary of Section Forty-one (41) Township Three (3) North Range
Twenty-six (26) East, thence in a Westerly direction along the
Southern boundary of Section Forty-one (41) Township Three (3)
North Range Twenty-six (26) East and continue the Southern boundaries
of Sections Thirty-five (35), Thirty-four (34), Thirty-three (33),

Thirty-two (32), and Thirty-one (31) Township Three (3) North Range Twenty-six (26) East and continuing along the Township line between Township Three (3) North and Two (2) North to the Southeast corner of Section Thirty-five (35) Township Three (3) North Range Twenty-five (25) East, thence in a Southerly direction along the Eastern boundaries of Sections Two (2) and Eleven (11) Township (2) North Range Twenty-five (25) East to the intersection with the Southeast corner of Section Eleven (11) Township Two (2) North Range Twentyfive (25) East, thence in a Westerly direction along the Southern boundaries of Section Eleven (11), Ten (10), Nine (9), Eight (8), and Seven (7) Township Two (2) North Range Twenty-five (25) East and continue along the Southern boundary of Section Twelve (12) Township Two (2) North Range Twenty-four (24) East to the intersection with the center line of the Seaboard Coastline Railroad Tracks, thence in a Northerly and Westerly direction along the center line of said railroad tracks to the intersection with the low water of the St. Marys River, thence in an Easterly direction along the low water mark of the St. Marys River to the center line of Interstate Highway No. Ninety-five (95) and point of beginning. The polling place for said Precinct No. Eight (8) is hereby designated and established at the Masonic Temple, in the Town of Hilliard, Nassau County, Florida.

Election District or Precinct No. 9

Beginning at the point where the center line of the Seaboard Coastline Railroad Tracks intersect with the low water mark of the St. Marys River, thence proceed in a Southerly direction along the low water mark of the St. Marys River to its intersection with a prolongation of the center line State Road No. Two (2), thence in

an Easterly direction along the prolongation of the center line of State Road No. Two (2) and continue along the center line of the Crawford Kent Road to its intersection with the Eastern boundary of Section Three (3) Township One (1) North Range Twenty-three (23) East, thence in a Northerly direction along the Eastern boundaries of Section Three (3) Township One (1) North Range Twenty-three (23) East and continue along the Eastern boundaries of Sections Thirtyfour (34), Twenty-seven (27), Twenty-two (22) and Fifteen (15) Township Two (2) North Range Twenty-three (23) East to the intersection with the Southwest corner of Section Eleven (11) Township Two (2) North Range Twenty-three (23) East, thence in an Easterly direction along the Southern boundaries of Sections Eleven (11) and Twelve (12) Township Two (2) North Range Twenty-three (23) East and continue along the Southern boundaries of Sections Seven (7), Eight (8), Nine (9), Ten (10), Eleven (11), and Twelve (12) Township Two (2) North Range Twenty-four (24) East to the intersection with the center line of the Seaboard Coastline Railroad Tracks, thence in a Northerly and Easterly direction along the center line of said railroad tracks to the low water mark of the St. Marys River and point of beginning. The polling place for said Precinct No. Nine (9) is hereby designated and established at the County owned Recreation Building, in the Town of Hilliard, Nassau County, Florida.

Election District or Precinct No. 10

Beginning at the point where the prolongation of the center line of State Road No. Two (2) intersects with the low water mark of the St. Marys River, thence proceed in a Southerly direction along the low water mark of the St. Marys River to its intersection

with the Western boundary of Section Thirty-one (31) Township One (1) South Range Twenty-three (23) East, thence in a Southerly direction along the Western boundary of Section Thirty-one (31) Township One (1) South Range Twenty-three (23) East to its intersection with the Southern side of said same Section (the Nassau-Duval County line), thence in an Easterly direction along the Southern boundaries of Sections Thirty-one (31), Thirty-two (32), Thirty-three (33), Thirty-four (34), Thirty-five (35), and Thirtysix (36) Township One (1) South Range Twenty-three (23) East to the intersection with the Nassau-Duval County line, thence in a Northerly and Easterly direction along the Nassau-Duval County line to the Southeastern corner of Section Thirty-six (36) Township One (1) North Range Twenty-four (24) East, thence in a Northerly direction along the Range line between Range Twenty-four (24) East and Range Twenty-five (25) East to the Northeast corner of Section Twenty-four (24) Township One (1) North Range Twenty-four (24) East, thence in a Westerly direction along the Northern boundaries of Sections Twenty-four (24), Twenty-three (23) and Twenty-two (22) Township One (1) North Range Twenty-four (24) East to the Southeastern corner of Section Sixteen (16) Township One (1) North Range Twenty-four (24) East, thence in a Northerly direction along the Eastern boundary of Section Sixteen (16) Township One (1) North Range Twenty-four (24) East to the Northeast corner of said Section Sixteen (16), thence in a Westerly direction along the Northern boundaries of Sections Sixteen (16), Seventeen (17), and Eighteen (18) Township One (1) North Range Twenty-three (23) East and continue along the Northern boundaries of Sections Nine (9) and Ten (10) Township One (1) North Range Twenty-three (23) East to the Southeast corner of Section Six (6) Township One (1) North Range Twenty-three (23) East, thence in a Northerly direction along the

Eastern boundaries of Section Six (6) and Three (3) Township One (1) North Range Twenty-three (23) East to the intersection with the center line of the Crawford Kent Road, thence in a Westerly direction along the center line of the Crawford Kent Road and continue in a Westerly direction along the center line of State Road No. Two (2) to the low water mark of St. Marys River and point of beginning. The polling place for said Precinct No. Ten (10) is hereby designated and established at the Fire Station located at the intersection of Motes Road and State Road No. Two Hundred (200), in the Community of Bryceville, Nassau County, Florida.

Election District or Precinct No. 11

Beginning at the point where the center line of State Road No. Two Hundred (200) intersects with the Southern boundary of Section Fifteen (15) Township One (1) North Range Twenty-three (23) East, thence proceed in a Northerly and Easterly direction along the center line of State Road No. Two Hundred (200) to its intersection with the Eastern boundary of Section Fourteen (14) Township Two (2) North Range Twenty-five (25) East, thence in a Northerly direction along the Eastern boundary of Section Fourteen (14) Township Two (2) North Range Twenty-five (25) East to the Northeast corner of said Section, thence in a Westerly direction along the Northern boundaries of Sections Fourteen (14), Fifteen (15), Sixteen (16), Seventeen (17), and Eighteen (18) Township Two (2) North Range Twenty-five (25) East and continuing along the Northern boundaries of Sections Thirteen (13), Fourteen (14), Fifteen (15), Sixteen (16), Seventeen (17), and Eighteen (18) Township Two (2) North Range Twenty-four (24) East and continuing along a prolonga-

tion of the Northern boundaries of Sections Thirteen (13) and Fourteen (14) Township Two (2) North Range Twenty-three (23) East (including part of Section Thirty-eight (38) Township Two (2) North Range Twenty-three (23) East) to the intersection with a prolongation of the Western boundary of Section Fourteen (14) Township Two (2) North Range Twenty-three (23) East, thence in a Southerly direction along a prolongation of the Western boundaries of Sections Fourteen (14), Twenty-three (23), Twenty-six (26), and Thirty-five (35) Township Two (2) North Range Twenty-three (23) East and continuing along the Western boundaries of Section Two (2) and Seven (7) Township One (1) North Range Twenty-three (23) East to the Southwest corner of said Section Seven (7), thence in an Easterly direction along the Southern boundaries of Sections Seven (7) and Eight (8) Township One (1) North Range Twenty-three (23) East and continuing along the Southern boundaries of Sections Seven (7), Eight (8) and Nine (9) Township One (1) North Range Twenty-four (24) East to the Southwest corner of Section Ten (10) Township One (1) North Range Twenty-four (24) East, thence in a Southerly direction along the Western boundary of Section Fifteen (15) Township One (1) North Range Twenty-four (24) East to the Southwest corner of said Section Fifteen (15), thence in an Easterly direction along the Southern boundary of Section Fifteen (15) Township One (1) North Range Twenty-four (24) East to the center line of State Road No. Two Hundred (200) and point of beginning. The polling place for Precinct No. Eleven (11) is hereby designated and established at the County Health Clinic on Mickler Street, in the Town of Callahan, Nassau County, Florida.

Election District of Precinct No. 12

Beginning at the point where a prolongation of the center line of Interstate Highway No. Ninety-five (95) intersects with the

low water mark of the Nassau Sound, thence proceed in a Northerly direction along the prolongation of the center line of Interstate Highway No. Ninety-five (95) to its intersection with the Northern boundary of Section Thirty-nine (39) Township Two (2) North Range Twenty-six (26) East, thence in a Westerly direction along the Northern boundaries of Sections Thirty-nine (39), Two (2), Three (3), Four (4), Five (5) and Six (6) Township Two (2) North Range Twentysix (26) East and continue along the Township line between Township Three (3) North and Two (2) North to the Northwest corner of said Section One (1), thence in a Southerly direction along the Western boundaries of Sections One (1), Twelve (12) and Thirteen (13) Township Two (2) North Range Twenty-five (25) East to the intersection with the center line of State Road No. Two Hundred (200), thence in a Southerly and Westerly direction along the center line of State Road No. Two Hundred (200) to its intersection with the Southern boundary of Section Fifteen (15) Township One (1) North Range Twentyfour (24) East, thence in an Easterly direction along the Southern boundaries of Sections fifteen (15), Fourteen (14), and Thirteen (13) Township One (1) North Range Twenty-four (24) East to the intersection with the Range line between Range Twenty-four (24) East and Range Twenty-five (25) East, thence in a Southerly direction along said Range line to the intersection with the Nassau-Duval County line, thence in a Northerly and Easterly direction along the Nassau-Duval County line and continue along the meanderings of Thomas Creek and the low water mark of the Nassau Sound to the center line of Interstate Highway No. Ninety-five (95) and point of beginning. polling place for Precinct No. Twelve (12) is hereby designated and established at the Lion's Club Building at 417 Fourth (4th) Avenue West, Town of Callahan, Nassau County, Florida.
