

RESOLUTION

A RESOLUTION AUTHORIZING A. RAY BEVILLE, CHAIRMAN, NASSAU COUNTY BOARD OF COUNTY COMMISSIONERS, TO INITIATE THE PROCEDURES NECESSARY TO UPGRADE THE COMMUNICATIONS SYSTEM OF THE NASSAU COUNTY SHERIFF'S OFFICE.

WHEREAS, the Nassau County Board of Commissioners, "Applicant", after thorough consideration of the problem and available data, has hereby determined that the project described below is in the best interests of the general public:

Communications Improvement Project-- Nassau County, The objective of this project is to up-grade the communications system of the Nassau County Sheriff's Office in accordance with the State Communications Master Plan, by the installation of a microwave system between Callahan, Florida and Fernandina Beach, Florida, as called for in Project 72-23-13 and planned for in the Region III Communications System and Equipment Plan.

WHEREAS, under the terms of public Law 93-83, the United States of America has authorized the Law Enforcement Assistance Administration, through the Bureau of Criminal Justice Planning and Assistance of the Florida Department of Administration, to make Federal Grants to assist local governments in the improvement of criminal justice; and

WHEREAS, the Applicant has examined and duly considered such Act and the Applicant considers it to be in the public interest and to its benefit to file an application under said Act and to authorize other action in connection therewith, NOW THEREFORE BE IT RESOLVED BY THE NASSAU COUNTY BOARD OF COMMISSIONERS, IN MEETING ASSEMBLED IN THE CITY OF FERNANDINA BEACH, FLORIDA, THIS 2nd DAY OF JULY, 1974, AS FOLLOWS:

1. That the project generally described above is in the best interest of the Applicant and the general public.
2. That A. RAY BEVILLE, Chairman, Nassau County Board of Commissioners, is authorized to submit an application in the form prescribed by the Bureau of Criminal Justice Planning and Assistance in conformity with said Act, for a grant to be made to the Applicant to assist in defraying the cost of the project generally described above.
3. That if such grant be made, the Applicant shall provide or make necessary arrangements to provide such funds in addition to the grant as may be required by the Act to defray the cost of the project generally described above.

4. That said A. RAY BEVILLE, Chairman, Nassau County Board of Commissioners, IS HEREBY AUTHORIZED TO FURNISH SUCH INFORMATION AND TAKE SUCH OTHER ACTION AS MAY BE NECESSARY TO ENABLE THE APPLICANT TO QUALIFY FOR SAID GRANT.

5. That the official designated in the preceding paragraph is hereby designated as the authorized representative of the Applicant for the purpose of furnishing to the BUREAU OF CRIMINAL JUSTICE PLANNING AND ASSISTANCE such information, data and documents pertaining to the application for said grant as may be required and otherwise to act as the authorized representative of the Applicant in connection with this application.

6. That certified copies of this resolution be included as part of the application for said grant to be submitted to the BUREAU OF CRIMINAL JUSTICE PLANNING AND ASSISTANCE.

7. That if such grant be made, the applicant or Official designated in paragraph 4 above shall maintain such records necessary and furnish such information, data and documents as required by the BUREAU OF CRIMINAL JUSTICE PLANNING AND ASSISTANCE to support the implementation of the project generally described above.

8. That this resolution shall take effect immediately upon its adoption.
