## RESOLUTION NO. 266

RESOLUTION OF BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, DESIGNATING AND ESTABLISHING NEW POLLING PLACES FOR PRECINCTS NUMBERS 6, 9, 11 AND 12; AND AMENDING THE AREAS ENCOMPASSED BY DISTRICTS OR PRECINCTS NUMBERS 8 AND 9.

WHEREAS, the Board of County Commissioners did on the 26th day of February, 1974, in a regular meeting duly assembled pass Resolution No. 169, and

WHEREAS, the Board of County Commissioners did on the 28th day of October, 1975, in a regular meeting duly assembled pass Resolution No. 234 amending Resolution No. 169, and

WHEREAS, the Board has determined the polling places for districts or precincts Numbers 6, 9, 11 and 12 need to be amended, modified and changed, and

WHEREAS, the Board has determined that the boundaries for districts and precincts 8 and 9 need to be amended, modified and changed, and

WHEREAS, the Board feels that the requirements of <u>Fla. Stat.</u> §101.73 (1973) could more fittingly be complied with by a new scheme of election districts and precincts.

NOW, THEREFORE BE IT RESOLVED, by the Board of County Commissioners of Nassau County, Florida, that the election districts and precincts for Nassau County together with the respective polling places as adopted by Resolution No. 169 and amended by Resolution No. 234 are hereby altered, and changed in the following respects only and designated and established as follows:

The polling place for Election District or Precinct No. 6 is hereby designated and established at the County owned Building in the Community of O'Neal, Nassau County, Florida.

The polling place for Election District or Precinct No. 9 is hereby designated as the County Building in the Town of Hilliard, Nassau County, Florida.

The polling place for Election District or Precinct No. 11 is hereby designated as the County Building in the Town of Callahan, Nassau County, Florida.

The polling place for Election District or Precinct No. 12 is hereby designated as the Town Hall in the Town of Callahan, Nassau County, Florida.

## Election District or Precinct No. 8

Beginning at the point where a prolongation of the center line of Interstate Highway No. Ninety-Five (95) intersects with the low water mark of the St. Marys River, thence proceed in a Southerly direction along the prolongation of the centerline of Interstate Highway No. Ninety-Five (95) to its intersection with the Southern boundary of Section Forty-One (41) Township Three (3) North Range Twenty-Six (26) East, thence in a Westerly direction along the Southern boundary of Section Forty-One (41) Township Three (3) North Range Twenty-Six (26) East and continue the Southern boundaries of Section Thirty-Five (35), Thirty-Four (34), Thirty-Three (33), Thirty-Two (32) and Thirty-One (31) Township Three (3) North Range Twenty-Six (26) East and continuing along the Township line between Township Three (3) North and Two (2) North to the Southeast corner of Section Thirty-Five (35) Township Three (3) North Range Twenty-Five (25) East, thence in a Southerly direction along the Eastern boundaries of Section Two (2) and Eleven (11) Township Two (2) North Range Twenty-Five (25) East to the intersection with the Southeast corner of Section Eleven (11) Township Two (2) North Range Twenty-Five (25) East, thence in a Westerly direction along the Southern boundaries of Section Eleven (11), Ten (10), Nine (9), Eight (8) and Seven (7) Township Two (2) North Range Twenty-Five (25) East and continue along the Southern boundary of Section Twelve (12) Township Two (2) North Range Twenty-Four (24) East to the point of

intersection between the centerline of the Railroad districts and the intersection of a prolongation of the centerline of Kings Road, thence continue in a Northerly and Westerly direction along the centerline of Kings Road to a prolongation of a centerline of Third Street. Thence in a Westerly direction along the centerline of Third Street to the point of intersection with the centerline of the Seaboard Coastline Railroad tracks, thence in a Northerly and Westerly direction along the centerline of said Railroad tracks to the intersection of the low water mark of the St. Marys River.

The polling place for said Precinct No. Eight (8) is hereby designated and established at the Masonic Temple, in the Town of Hilliard, Nassau County, Florida.

## Election District or Precinct No. 9

Beginning at the point where the centerline of the Seaboard Coastline Railroad tracks intersect with the low water mark of the St. Marys River, thence proceed in a Southerly direction along the low water mark of the St. Marys River to its intersection with a prolongation of the centerline of State Road No. Two (2), thence in an Easterly direction along the prolongation of the centerline of State Road No. Two (2) and continue along the center line of the Crawford Kent Road to its intersection with the Eastern boundary of Section Three (3) Township One (1) North Range Twenty-Three (23) East, thence in a Northerly direction along the Eastern boundaries of Section Three (3) Township One (1) North Range Twenty-Three (23) East and continue along the Eastern boundaries of Sections Thirty-Four (34), Twenty-Seven (27), Twenty-Two (22) and Fifteen (15) Township Two (2) North Range Twenty-Three (23) East to the intersection with the Southwest corner of Section Eleven (11) Township Two (2) North Range Twenty-Three (23) East, thence in an Easterly direction along the Southern boundaries of Sections Eleven (11) and Twelve (12) Township Two (2) North Range Twenty-Three (23) East and continue along the Southern boundaries of Sections Seven (7), Eight (8), Nine (9), Ten (10), Eleven (11) and Twelve (12) Township Two (2) North Range Twenty-four (24) East to the point of intersection between the centerline of the Railroad districts and the intersection of a prolongation of the centerline of Kings Road, thence continue in a Northerly and Westerly direction along the centerline of Kings Road to a prolongation of a centerline of Third Street.

Thence in a westerly direction along the centerline of third street to the point of intersection with the centerline of the Seaboard Coastline Railroad tracks, thence in a northerly and westerly direction along the centerline of said railroad tracks to the intersection of the low water mark of the St. Marys River.
