

A RESOLUTION APPROVING THE

DISTRICT MENTAL HEALTH PLAN

FOR JULY 1, 1977 TO JUNE 30,

1978, OF THE MENTAL HEALTH

BOARD OF HRS DISTRICT IV; PRO-

VIDING AN EFFECTIVE DATE.

WHEREAS, Part IV of Chapter 394 of the Florida Statutes establishes mental health boards within the various districts of the State of Florida, Department of Health and Rehabilitative Services and such a board has been established for said Department's District IV which includes Nassau County, and

WHEREAS, Section 394.75 requires that the Mental Health Board of HRS District IV prepare a certain district mental health plan and submit same to the various governing bodies within its district for review, comment and approval, and

WHEREAS, the Board of County Commissioners has reviewed and commented on said plan, now therefore,

BE IT RESOLVED by the Board of County Commissioners of Nassau County:

Section 1. Having reviewed and commented on the district mental health plan for July 1, 1977, through June 30, 1978, of the Mental Health Board of HRS District IV, a copy of said plan on file in the Office of the Clerk of the Board of County Commissioners, the Board of County Commissioners hereby approves said plan. Nothing herein shall be or construed to be any appropriation or obligation to appropriate any amount of funds.

Section 2. This resolution shall become effective upon signature of the Chairman.




