
WHEREAS the Clerk of Circuit and County Court of Nassau County is required by Chapter 142.03, Florida Statutes, to furnish the Board of County Commissioners "... a full report ... once in each month, within 30 days after the expiration of said month, of the amount of fines imposed by their courts and of bonds forfeited and judgments rendered on said forfeited bonds, and into whose hands they have been paid or placed for collection, the date of conviction in each case, the term of imprisonment, and the name of the officer to whom commitment was delivered."

WHEREAS the Clerk of Circuit and County Court advises the Board that this report involves some 15,000 cases a year and that the production of said report would take one full-time employee.

WHEREAS the Clerk of Circuit and County Court advises the Board that this information is fully documented in the records in the Clerk's Office through receipts, docket books and financial deposition reports and accessible to the Board or the general public.



Said report to be made at the end of each month.
