In addition to the punishment prescribed herein, any nets, boats, vehicles or paraphernalia used in the violation of the provisions of this act shall be seized and, upon the conviction of the offender, shall be confiscated or destroyed as provided by Section 370.061, Florida Statutes, Section 5.

Be it enacted by the Legislature of the State of Florida:

SECTION I: It shall be unlawful for any person, firm or corporation to use or cause to be used or commit any overt act toward the use of any type of gill net in the inside salt waters of Nassau County without a permit issued by the Division of Marine Resources of the Department of Natural Resources.

SECTION II: Applications for permits shall be made on forms to be supplied by the Division, which shall require the applicant to furnish such information as may be deemed pertinent to the best interest of salt water conservation. The fee for such permits shall be \$250.00 per year. Each permit shall entitle the holder thereof to use no more than one gill net at any one time in the inside salt waters of Nassau County. The permitted net must be attended by the permit holder. The Division may refuse to grant any permit when it is apparent that the best interests of salt water conservation will be served by such denial. A11 permits granted shall be in the holders possession whenever the holder is engaged in using a gill net. Each permit is subject to immediate revocation upon conviction of a violation of any provision of this act or when it is apparent that the best interests of salt water conservation will be served by such revocation.

Be it enacted by the Legislature of the State of Florida: SECTION I: The use of any type of net or seine, other than a common cast net or a recreational net as hereinafter defined, is prohibited in the inside salt waters of Nassau County between May 1st and September 15th each year.

SECTION II: It shall be unlawful for any person, firm or corporation to use any type of net or seine, other than a common cast net or recreational net as hereinafter defined, within the inside salt waters of Nassau County between May 1st and September 15th of each year.

SECTION III: It shall be unlawful for any person, firm or corporation to fish or cause to be fished or commit any overt act toward the use of any type of net or seine other than the above stated exceptions, within the inside salt waters of Nassau County between May 1st and September 15th of each year.

SECTION IV: The term "recreational net" means a seine or similar net not exceeding 100 feet in length with mesh no smaller than 2½ inches set and hauled solely by hand and without use of any motor driven boat or vehicle.

SECTION V: Any person, firm or corporation violating any provision of this act shall be guilty of a misdemeanor of the first degree and shall be punished as provided in Section 775.082 and Section 775.083, Florida Statutes. In addition to the punishment prescribed herein, any nets, boats, vehicles or paraphernalia used in the violation of the provisions of this act shall be seized and, upon conviction of the offender, shall be confiscated or destroyed as provided by Section 370.061, Florida Statutes, Section 5.
