

RESOLUTION NO.: 83-25

A RESOLUTION PROVIDING FOR THE ISSUING OF BEACH PERMIT STICKERS; PROVIDING FOR THE CONTROL AND LOCATION OF SAID STICKERS AND PROVIDING FOR ENFORCEMENT PROCEDURES.

WHEREAS, the Board of County Commissioners of Nassau County has determined that an Ordinance is necessary to levy a \$15.00 seasonal fee for motor vehicle use on the County beaches, and

WHEREAS, said Ordinance has been found to be necessary for the protection of the health, safety and welfare of the citizens and the beach environment, and

WHEREAS, the County Commissioners enacted Ordinance number 83-11 which references a Resolution,

THEREFORE, BE IT RESOLVED, by and Board of County Commissioners of Nassau County hereby adopts the following permit, collection and enforcement procedures:

1.) A vehicle permit shall be issued by the Clerk's Office and other designated retail stores. Said permits shall be issued upon receipt of a \$15.00 seasonal fee.

2.) The permits shall be available for sale to the public:

(a) Monday through Friday at the Clerk's Office during normal working hours.

(b) Retail stores in Nassau County during their regular hours.

3.) All vehicle permits shall be conspicuously displayed on the windshield (lower left hand side of the motor vehicle for which the permit was granted). If the motor vehicle does not have a windshield, the permit shall be conspicuously displayed on the rear bumper.

4.) One (1) permit shall be issued per vehicle. A permit may be transferred upon payment of a \$2.00 transfer fee and presentation of the permit to the Clerk's office. Said permit shall be destroyed by the Clerk's office.

5.) There shall be no permit fee required for vehicle owners that are age 65 and over. A special colored permit shall be issued upon vehicle registration and proof of age without a fee.

6.) The Clerk's Office shall be responsible for the control, distribution and accountability of the beach permit stickers.

7.) The Clerk's office and each retail outlet shall be entitled to collect, for the sale of each permit, an amount up to \$1.00 for each permit. Said charge shall be a handling charge and shall be deducted from the \$15.00 amount of each permit that is to be paid to the county. No retail outlet shall charge an amount higher than \$15.00 for each permit. Any retail outlet charging more than \$15.00 shall forfeit the privilege of selling said permits.

8.) Ordinance 83-11 shall be enforced according to the provisions contained therein and as supplemented by the provisions of this Ordinance.

9.) The Clerk of the Circuit Court shall devise accounting and control procedures for the sale and handling of the permits. Said procedures shall be approved by the Board of County Commissioners. Each retail outlet shall be governed by those procedures.

10.) All permits shall be valid for the 1983 season which shall be from May 1, 1983, until September 30, 1983. In all succeeding years, the seasonal period shall be as stated in the Ordinance - April 1st through September 30th.
