A RESOLUTION SETTING THE TIME AND PLACE FOR PUBLIC HEARING ON THE VACATION OF A PORTION OF A RECORDED PLAT HEREIN DESCRIBED, AND THE RENOUNCING AND DISCLAIMING OF ANY RIGHT OR INTEREST OF SAID NASSAU COUNTY, FLORIDA, AND THE PUBLIC IN SAID LANDS AND RETURNING THE PROPERTY COVERED BY SUCH PLAT INTO ACREAGE.

WHEREAS, AMELIA PLANTATION COMPANY, has petitioned the Board of County Commissioners of Nassau County, Florida, to vacate and to renounce and disclaim the right and interest of Nassau County, Florida, and the public in and to a portion of a recorded subdivision described as follows:

Lots 1, 54, 55, 56, 57, 62, 63, 64 and 65, Beach Wood Village, Unit I as recorded in Plat Book 4, pages 25-27.

WHEREAS, Section 171.101 Florida Statutes, authorized this Board to vacate plats in whole or in part and to renounce and disclaim the right and interest of Nassau county, Florida, an of the public in and to lands convered by such plats, returning the property covered by such plats either whole or in part into acreage after giving notice of and holding a public hearing to determine whether such action should be taken.
