Please be advised, at this time, the referenced crossing is in the Safety Program for railroad signal installation the fiscal year 1982-83. This crossing was selected on a state-wide priority.

The estimated installation cost of Type I, Class I signals at this location is \$40,000. The Federal Highway Administration agrees to pay ninety percent (90%) and the Florida Department of Transportation will be responsible for the remaining ten percent (10%) of the total installation cost. The annual maintenance cost of Type I, Class I signals at this location is \$650. The County of Nassau is responsible for fifty percent (50%) of the annual maintenance cost and the railroad company is responsible for the remaining fifty percent (50%).

The County of Nassau will be responsible for installation of advance warning singns and pavement markings per Department of Transportation Index 17882.

A resolution is required by the Department from the County of Nassau before any preliminary engineering can be started by the railroad company.
