FERNANDINA BEACH RESOLUTION NO: 831

A JOINT RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, AND THE CITY OF FERNANDINA BEACH, FLORIDA, ADOPTING AN INTERLOCAL AGREEMENT FOR THE ESTABLISHMENT OF A LOCAL PLANNING AGENCY FOR THE DESIGN, DEVELOPMENT AND IMPLEMENTATION OF A COMPREHENSIVE LAND USE PLAN FOR ALL OF AMELIA ISLAND, FLORIDA

WHEREAS, Nassau County and the City of Fernandina Beach are required by Chapter 163, Florida Statutes, to revise and update their respective comprehensive land use plans for their respective jurisdictions; and

WHEREAS, the Board of County Commissioners of Nassau County and City Commission of the City of Fernandina Beach deem it appropriate, necessary and in the best interests of the citizens of Amelia Island, Florida, to adopt a joint comprehensive land use plan for all of the incorporated and unincorporated areas of Amelia Island, Florida;

Now, Therefore, BE IT RESOLVED, by the Board of County Commissioners of Nassau County, Florida, and the City Commission of the City of Fernandina Beach, Florida, as follows:

1. That Nassau County ("County") and City of Fernandina Beach ("City") do hereby agree to each adopt a Joint Comprehensive Land Use Plan for all of the incorporated and unincorporated areas of Amelia Island, in Nassau County, Florida, in accordance with Florida Statutes, Chapter 163.

2. That County and City shall designate and establish a joint local planning agency for Amelia Island, as such is contemplated and required by § 163.3174, F.S., which shall prepare the Comprehensive Plan and make recommendations to County and City regarding the adoption of such plan.

3. The Joint Local Planning Agency shall consist of eleven (11) members, five of whom shall be appointed by County, five of whom shall be appointed by City, and the eleventh member who shall be appointed jointly by City and County.

The initial County appointees shall be: JoAnn Kirkland,

Anne Coonrod, Kelly Walker, Michael S. Mullin and James McLaughlin. The initial City appointees shall be: F. R. Cole, Wesley R. Poole, James Schroads, James Bartelt, and Lenda Cook. The initial eleventh joint appointee shall be Roselyn Simon.

4. The Joint Local Planning Agency shall be charged with those duties and responsibilities for the conduct of the comprehensive planning program as set forth in §163.3174, Florida Statutes.

5. Both City and County agree to appropriate the necessary funds to implement the Joint Amelia Island Comprehensive Plan according to a budget recommended by the Joint Land Planning Agency established herewith and approved by City and County.

ADOPTED at meetings duly noticed and scheduled, by the Board of County Commissioners on November 6, 1986, and by the City Commission of the City of Fernandina Beach, on November 4, 1986.
