## **RESOLUTION 87-48**

A RESOLUTION SETTING THE TIME AND PLACE FOR PUBLIC HEARING ON THE CLOSING, VACATING AND ABANDONING OF THOSE CERTAIN RIGHTS-OF-WAY OR ALLEYS IN THE HEREIN DESCRIBED PROPERTY, AND THE RENOUNCING AND DISCLAIMING OF ANY RIGHT OR INTEREST OF SAID NASSAU COUNTY, FLORIDA, AND THE PUBLIC IN SAID RIGHTS OF WAY OR ALLEYS.

WHEREAS, CHAMPION INTERNATIONAL CORPORATION, has petitioned the Board of County Commissioners of Nassau County, Florida, to close, vacate and abandon and to renounce an disclaim the right and interest of Nassau County, Florida, and the public in and to those certain rights-of-way or alleys described as follows:

Avenues and streets appearing on the plat of "The Town of Crawford" which exist only on the plat and have never been constructed or maintained being particularly described below.

29TH Street - a road running north and south through section 15, township 1 north, range 24 east, 60 feet wide between lots 1199 and 1200, 1211 and 1212, 1215 and 1216, 1227 and 1228, 1231 and 1232, 1243 and 1244, 1247 and 1248, 1259 and 1260.

WHEREAS, Section 336.09, Florida Statutes, authorizes this Board to close, vacate and abandon streets, roads and alleys and to renounce and disclaim the right and interest of Nassau County, Florida, an of the public in and to lands delineated on any recorded map or plat as a street, alley, road or highway outside of the corporate limits of any municipality after given notice of and holding a public hearing to determine whether such action should be taken. NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Nassau County, Florida, in a meeting duly assembled that a public hearing will be held on said petition at the Nassau County Courthouse Annex Building in Fernandina Beach, Florida, on the <u>18th</u> day of <u>August</u>, A.D. 1987, at <u>2:30</u> o'clock <u>p.m</u>.

BE IT FURTHER RESOLVED that notice of said meeting be published in the NASSAU COUNTY RECORD, a newspaper of general circulation in Nassau County, Florida, at least two weeks prior to the date of said hearing, said notice to be in substantially the form as indicated on the attached.
