A RESOLUTION VACATING AND ABANDONING THAT PORTION OF KERI ACRES MORE PARTICULARLY DESCRIBED AS LOTS 12 AND 13, UNIT 1, OF KERI ACRES.

WHEREAS, a public hearing was held at <u>2:30</u> o'clock <u>p.m.</u>, on the <u>22md</u> day of <u>December</u>, 1987, at the Nassau County Courthouse Annex Building, Nassau County, Florida, pursuant to a notice duly published as provided by law upon the petition of Braxton K. Musseau, requesting this Board to vacate and abandon the land hereinafter described and to renounce and disclaim the right of the public and the County to further consider the land hereinafter described as being a part of Keri Acres, a recorded subdidvision in book 0522, page 0734 of the official records of Nassau County, Florida.

Lots 12 and 13, Unit 1 of Keri Acres

WHEREAS, the land described will no longer be a part of Keri Acres, the land will hereinafter be described as follows:

> Being a part of Section 13, Township 2 North, Range 24 East, Nassau County, Florida, begin at a point of reference described as a concrete monument located at the Southeast corner of Section 13, Township and Range aforementioned; thence run South 88 50'59" West along the South line of said Section a distance of 180,22 feet; thence run North 56 56'10" West along the northeasterly right of way lone of County Road 115 (an 80.0 foot right of way) a distance of 1693.71 feet to the POINT OF BEGINNING; thence continue North 56 56'10" West for a distance of 508.52 feet to the beginning of a curve concave to the Northeasterly direction, continuing along said right of way and along the arc of said curve, passing through a central angle of 07 51'36": an arc distance of 151.71 feet (the aforesaid arc has a chord distance of 151.59 feet that bears North 53 00'22" West); run thence North 72 27'20" East a distance of 570.56 feet; run thence South 56 56'10" East a distance of 267.73 feet; thence South 33 02'56" West for a distnace of 425.00 feet to the POINT OF BEGINNING.




