

RESOLUTION 90-133





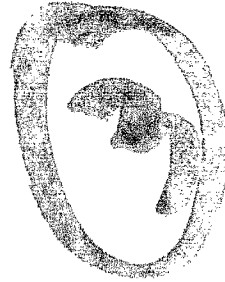
