The Chief Operations Officer reminded the Board of the correspondence from the Bryceville Fire Department inviting the Board to the Annual Fireman's Dinner to be held at the Western Sizzlin in Callahan on October 26, 1989 at 8:00 P.M.

Commissioner Testone made motion authorizing the Clerk using \$20,000 of excess funds at the end of the year, for renovations for his office space that would be moving to the old Ferreira Building, located on Centre Street, and that this shall be in addition to an approximate amount of \$25,000 of excess funds which will be turned in by his office. Motion seconded by Commissioner Branan and voted unanimously.

Commissioner Testone made motion approving the Florida Boating Improvement Program Development Project Agreement between Nassau County and the Florida Department of Natural Resources in pursuance of a recreational boating project to be known as Kings Ferry Boat Ramp approved under the Florida Boating Improvement Program, and instructed the Chairman to sign same. Motion seconded by Commissioner Branan and voted unanimously.

The Chief Operations Officer informed the Board that the Clerk's Office has received a telephone call from the Fernandina Beach News-Leader notifying them that ITT Rayonier will be celebrating their 50th anniversary and inquired whether the Board desired to place a congratulatory message in their anniversary issue. Commissioner Jones made motion that the Board shall place a congratulatory message measuring 1/8 of a page at a cost of \$85.00, with cost of same to be split and paid by each individual board member. Motion died for lack of a second.
