WHEREAS, the Board of County Commissioners of Nassau County, Florida, believe that the following changes are beneficial for the health, safety, and welfare of the citizens of Nassau county; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "TRADEWINDS WAY" (across from Martinique Lane); to the name of "MARTINIQUE COURT" due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "GULF STREAM LANE" located in section 12; township 2N; range 28E; to the name of "GULF STREAM COURT" due to a conflict in the 911 address grid; and
