

RESOLUTION 92-7

WHEREAS the Nassau County Impact Fee Ordinance Trust Fund has received impact fees pursuant to Ordinance 87-17 and Resolution 89-22. A 5% administrative fee is distributed to the Clerk of Courts and Building, Zoning, and Planning Department each.

WHEREAS these revenues were not anticipated in the 1990/91 for the Fund.

BE IT THEREFORE resolved by the Board of County Commissioners, Nassau County, Florida in regular session, duly assembled on the 14th day of October, 1991, the following budget amendment pursuant to Florida Statutes 129.06(2)(d) be adopted:
