

RESOLUTION 92 - 97

A RESOLUTION TO CHANGE THE FOLLOWING
STREET NAMES ON AMELIA ISLAND:

WHEREAS, the Board of County Commissioners of Nassau County, Florida, believe that the following changes are beneficial for the health, safety, and welfare of the citizens of Nassau County; and

WHEREAS, the following changes will help establish a consistent street naming and addressing grid for all emergency systems as is intended by the Nassau County Board of County Commissioners as stated in Ordinance 87-18 and Ordinance 88-23; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "AMELIA AVENUE" located in subdivision in section 4; located in section 4; township 2N; range 28E; to the name of "OLD AMELIA AVENUE" due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "AMELIA AVENUE" located in section 3; township 2N; range 28E; to the name of "AMELIA ROAD" due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "MAGNOLIA STREET" located in Sheffield Subdivision; located in section 4; township 2N; range 28E; to the name of "MAGNOLIA LANE"; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "PINE STREET" located in City of Fernandina Beach Subdivision; located in section 24; township 3N; range 28E; to the name of "PINE TRAIL" due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "PINE STREET" located in Pine Meadow Subdivision; located in section 5; township 2N; range 28E; to the name of "PINE ROAD" due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "KENNETH COURT" located in Subdivision in Section 4; located in section 5; township 2N; range 28E; to the name of "KENNETH AVENUE" due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "DUNEWOOD PLACE" located in the Golf Mar Subdivision; located in section 11; township 2N; range 28E; to the name of "DUNEWOOD LANE" due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "MARY STREET" (Mary Street appears to be an extension of Mary Avenue) located in American Beach Subdivision - unit II, section 3; located in section 20; township 2N; range 28E; to the name of "MARY AVENUE" due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "14TH STREET EXTENSION" (also known as BROOK ROAD) located in sections 3, 4, and 30; it extends through Ocean Breeze Farms Subdivision; townships 3N and 2N; range 28E; to the name of "SOUTH 14TH STREET" due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "1ST STREET" located in Saint Patrick's Cove Subdivision; located in section 30; township 3N; range 28E; to the name of "DONNIE LANE" due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "3RD STREET" located in Saint Patrick's Cove Subdivision; located in section 30; township 3N; range 28E; to the name of "HAGAN LANE" due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "4TH STREET" located in Saint Patrick's Cove Subdivision; located in section 30; township 3N; range 28E; to the name of "ROWLAND LANE" due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "CITRONA DRIVE", beginning on Sadler Road and continuing north to its terminus, located in section 29; township 3N; range 28E; to the name of "CITRONA DRIVE" due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "WILL HARDEE ROAD", beginning on Sadler Road and continuing South to its terminus, located in section 29; township 3N; range 28E; to the name of "WILL HARDEE ROAD" due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "EGANS BLUFF ROAD" located in Egans Bluff Subdivision - Unit I; located in section 2; township 2N; range 28E; to the name of "WILL HARDEE ROAD" due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "CLINCH ROAD" located in section 30; township 3N; range 28E; to the name of "CLINCH DRIVE"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "TEN ACRE ROAD" located in the South Part of Section 12 Subdivision; located in section 12; township 2N; range 28E; to the name of "PHILIPS MANOR ROAD" due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "RYAN ROAD" located in Sadler Estates Subdivision; located in section 32; township 3N; range 28E; to the name of "RYAN ROAD" north to Sadler Road due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "GROVE PARK BOULEVARD" located in Grove Park Subdivision; located in section 4; township 2N; range 28E; to the name of "GROVE PARK CIRCLE" due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "PECAN ROAD" located in Grove Park Subdivision; located in section 4; township 2N; range 28E; to the name of "GROVE PARK CIRCLE" due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "SHELL LANE" located in Grove Park Subdivision; located in section 4; township 2N; range 28E; to the name of "GROVE PARK CIRCLE" due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "WOOD STORK PLACE" located in Marsh Lakes Subdivision; located in section 37; township 6D; range 37S; to the name of "WOOD STORK LANE" due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "FIRST STREET" located in Oak Grove Subdivision; located in section 30; township 3N; range 28E; to the name of "MOURNING DOVE LANE" due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "SECOND STREET" located in Oak Grove Subdivision; located in section 30; township 3N; range 28E; to the name of "PELICAN LANE" due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named FOURTH STREET located in Oak Grove Subdivision; located in Section 30; township 3N; range 28E; to the name of "WAX WING LANE" due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "1ST AVENUE" located in Amelia Acres Subdivision; located in section 4; township 2N; range 28E; to the name of "SCRUB JAY LANE" due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "2ND AVENUE" located in Amelia Acres Subdivision; located in section 4; township 2N; range 28E; to the name of "BOBWHITE LANE" due to a conflict in the 911 address grid; and

WHEREAS, the Department of Emergency Services has requested the change of the road named "FISHLER ROAD" located near the Hutchins South Beach Subdivision; located in section 6, township 2N; range 29E; to the name of "SIMMONS ROAD" due to a conflict in the 911 address grid; and

WHEREAS, the Board of County Commissioners of Nassau County, Florida, believe that these changes will be beneficial for the citizens of Nassau County.

NOW, THEREFORE, BE IT RESOLVED that the above street names shall be changed and street signs shall be erected by the Road and Bridge Department to reflect these changes; and

BE IT FURTHER RESOLVED, that the Road and Bridge Department shall erect signs to reflect the following; and

A sign be placed at the Amelia Island Parkway indicating the change from "SOUTH FLETCHER AVENUE" to "GERBING ROAD" at this intersection; and

A sign be placed indicating the naming of the street "POGY PLACE" (north of Old Town) located in section 10; township 3N; and range 28E; and


A sign be placed at 8th Street intersection indicating the change from "SADLER ROAD" to "BONNIEVIEW ROAD"; and

A sign be placed at Gerbing Road intersection, indicating the change of "AMELIA ROAD" to "FLORIDA FIRST COAST HIGHWAY/BUCCANEER TRAIL"; and

Place appropriate signs indicating dual names for "FLORIDA FIRST COAST HIGHWAY/BUCCANEER TRAIL" from Gerbing Road south to the end of Amelia Island; and
