

RESOLUTION 93-1

WHEREAS the Fine and Forfeiture Fund has school resource revenue in excess of amount budgeted. Revenue received is a reimbursement of costs incurred by the Sheriff to provide an officer at West Nassau High School.

WHEREAS these revenues were not anticipated in the 1991/92 budget for the Fine and Forfeiture Fund.

BE IT THEREFORE resolved by the Board of County Commissioners, Nassau County, Florida in regular session, duly assembled on the 12th day of October, 1992, the following budget amendment pursuant to Florida Statutes Chapter 129.06(2)(d) be adopted:
