

RESOLUTION 94 -106

A RESOLUTION PROCLAIMING THE WEEK OF MAY 1, 1994, THROUGH MAY 7, 1994, AS "NATIONAL TOURISM WEEK".

WHEREAS, the tourism industry is a vital component of Nassau County's diverse economy, employing approximately one thousand six hundred (1,600) people on Amelia Island with a payroll in excess of \$21 million dollars; and

WHEREAS, lodging establishments comprise a significant share of the County's tax base; and

WHEREAS, tourism is an environmentally sound industry; and

WHEREAS, through the tourist development tax levy, the County benefits from services and amenities such as beach clean-up, the Tour of Homes, Victorian Seaside Christmas, the Kingfish Tournament, Fourth of July Festivities, and the forthcoming Stars and Stripes Over Amelia Island performance at the Fernandina Beach Airport; and

WHEREAS, many individuals engaged in the tourism industry play vital leadership and followership roles in the County's civic organization and philanthropic efforts.

NOW, THEREFORE, BE IT RESOLVED this 25th day of April, 1994, by the Board of County Commissioners of Nassau County, Florida, as follows:


1. The week of May 1, 1994, through May 7, 1994, is hereby designated and proclaimed as "NATIONAL TOURISM WEEK" in Nassau County, Florida. The County publicly expresses appreciation to






