

**WHEREAS**, the Board of County Commissioners of Nassau County, Florida, believe that these changes will be beneficial for the citizens of Nassau County.

**NOW, THEREFORE, BE IT RESOLVED** that the above street name shall be changed and street signs shall be erected by the Road and Bridge Department to reflect this new name designation.

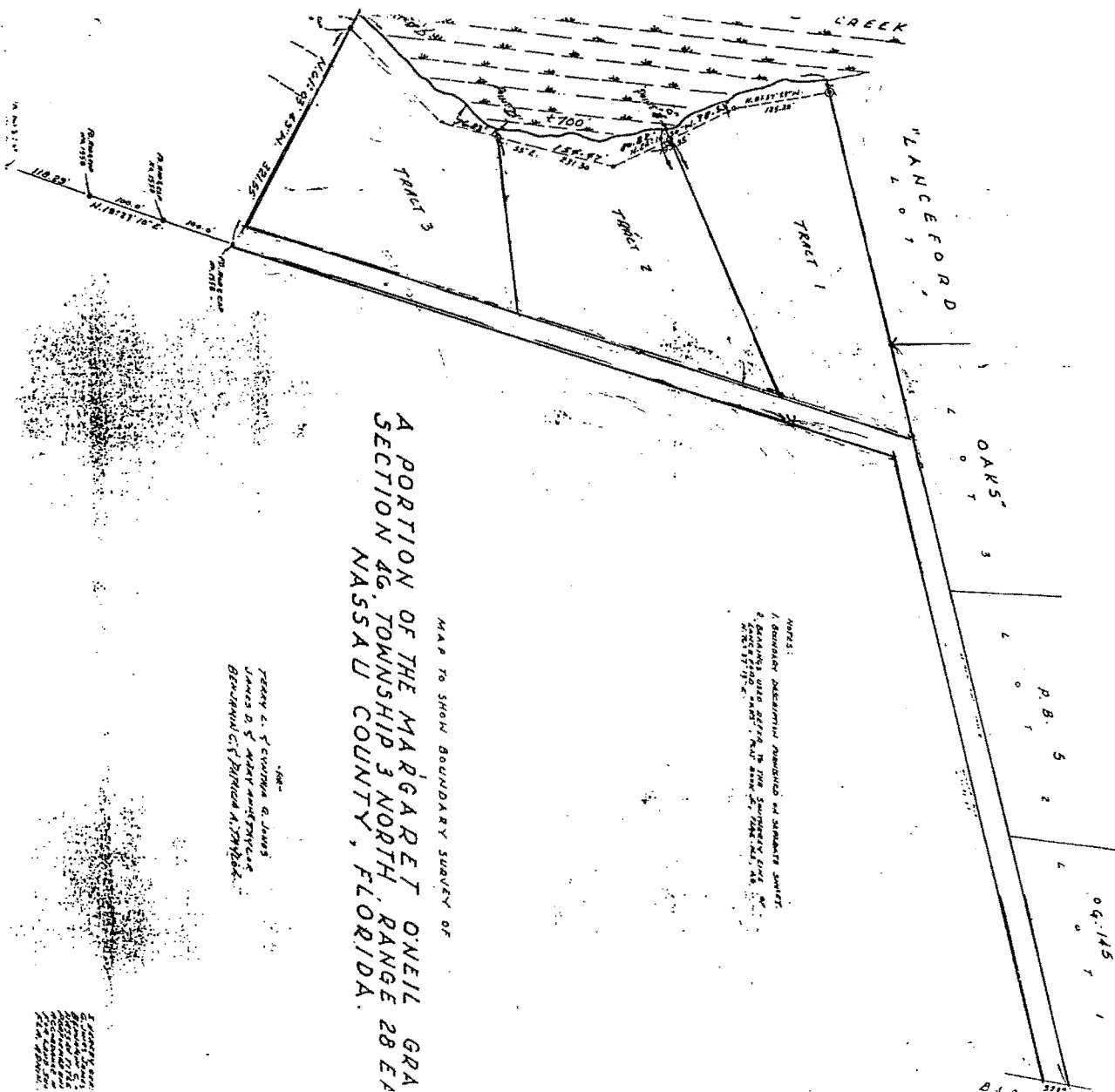
