WHEREAS, the Board of County Commissioners of Nassau County Florida did establish Ordinance Number 92-14 providing for a process of naming and renaming streets in Nassau County, and

WHEREAS, the majority of citizens of Nassau County currently residing on an **unnamed easement off Knights Road, Section 44, Township 4N, Range 28E**, requested that the street be renamed **R. L. Johnson Street**, and

WHEREAS, the residents understand that they must pay for the construction and placement of new street signs reflecting this change, and

WHEREAS, the 911 Coordinator's office has reviewed the request in accord with Ordinance Number 92-14, and has verified the request as acceptable and not in conflict with names already assigned, and


WHEREAS, the 911 Coordinator's office has forwarded the request to the Board of County Commissioners for consideration, now

It is the road marked in red and it is about 10 miles west of Williams, FL.

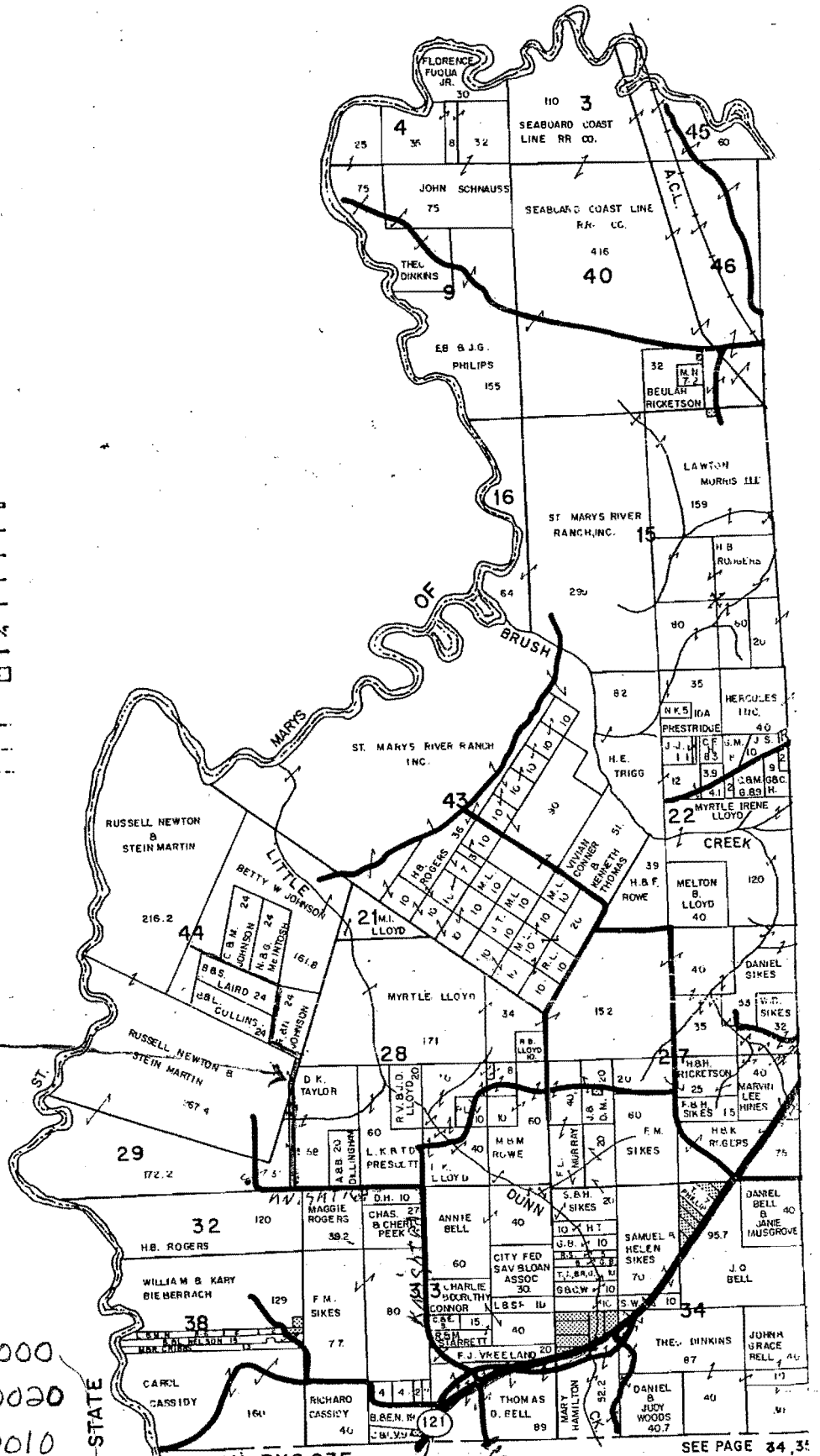
