A RESOLUTION TO CHANGE THE FOLLOWING STREET NAMES IN THE YULEE AREA FROM THE INTERCOASTAL WATER WAY TO 1-95

911 Operations Coordinator Linda P. Cox (904) 225-8977 (904) 879-4477 WHEREAS, the Board of County Commissioners of Nassau County, Florida, believe that the following changes are beneficial for the health, safety, and welfare of the citizens of Nassau County; and

WHEREAS the following changes will help establish a consistent street naming and addressing grid for all emergency systems as is intended by the Nassau County Board of County Commissioners as staed in Ordinance 87-18 and 88-23; and

WHEREAS, the Department of Public Safety has requested the unnamed road which "extends west off of North U. S. Highway 17"; located in Section 2; Township 3n; Range 26E; be named "LIPPIZAN COURT"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Public Safety has requested the unnamed road which "extends north off Owens Road just past the railroad tracks"; located in Section 41; Township 4n; Range 26E; be named "CORNING COURT" due to a conflict in the 911 address grid; and

WHEREAS, the Department of Public Safety has requested the unnamed road which "extends west off North U. S. Highway 17"; located in Section 41 and Section 50; Township 3N; Range 27E; be named "ANCHOR COURT"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Public Safety has requested the unnamed road which "extends north off East State Road 200"; located in Section 24, Township 2N; Range 28E; be named "BARON DRIVE" due to a conflict in the 911 address grid; and

WHEREAS, the Department of Public Safety has requested the unnamed road which "extends north off S. R. 108"; located in Section 41;

Township 3N; Range 26E; be named "SWITCHER LANE" due to a conflict in the 911 address grid; and

WHEREAS, the Department of Public Safety has requested the unnamed road which "extends north off North U. S. Highway 17"; located in Section 50; Township 3N; Range 27E; be named "HECTOR COURT" due to a conflict in the 911 address grid; and

WHEREAS, the Department of Public Safety has requested the "unnamed road which extends south off of Rose's Bluff Road"; located in Section 42; Township 3N; Range 28E; be named "ADDISON PLACE"; due to a conflict in the 911 address grid; and

WHEREAS, THE Board of County Commissioners of Nassau County, Florida, believe that these changes will be beneficial for the citizwns of Nassau County.

NOW, THEREFORE, BE IT RESOLVED that the above street names shall be changed and street signs shall be erected by the Road and Bridge Department to reflect these changes, and new name designations.
