WHEREAS, the Board of County Commissioners of Nassau County, Florida, believe that the following changes are beneficial for the health, safety, and welfare of the citizens of Nassau County; and

WHEREAS, the following changes will help establish a consistent street naming and addressing grid for all emergency systems as is intended by the Nassau County Board of County Commissioners as stated in Ordinance 87-18 and Ordinance 88-23; and

WHEREAS, the Department of Public Safety has requested that the road named "**LENTS ROAD**"; located in the Griffin Tract Subdivision; in Section 37; Township 3N; Range 27E; be changed to "**RADDIN ROAD**"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Public Safety has requested that named "**JERSEY STREET**"; located in Section 51; Township 3N; Range 27; be changed to "**EZELL LANE**"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Public Safety has requested that the road named "**SPICEWOOD AVENUE**"; located in Section 42; Township 2N; Range 27E; be changed to "**FERGUSON AVENUE**"; due to a conflict in the 911 address grid; and

WHEREAS, the Department of Public Safety has requested that the road named "**VERO AVENUE**"; located in Section 51; Township 3N; Range 27E; be changed to "**CONVERSE LANE**"; due to a conflict in the 911 address grid; and


WHEREAS, the Department of Public Safety has requested that the road named "**BELLS RIVER ESTATES ROAD**"; located in Section 38; Township 3N; Range 27; be changed to "**BELL RIVER ESTATES ROAD**"; due to a conflict in the 911 address grid; and

WHEREAS, the Board of County Commissioners of Nassau County, Florida, believe that these changes will be beneficial for the citizens of Nassau County

NOW, THEREFORE, BE IT RESOLVED that the above street names shall be changed and street signs shall be erected by the Road and Bridge Department to reflect these changes, and new name designations.


