WHEREAS monies that were encumbered in 94/95 but were not spent are to be carried over to the 1995/96 budget year.

WHEREAS these revenues were not anticipated in the 1995/96 budget.

BE IT THEREFORE resolved by the Board of County Commissioners, Nassau County, Florida in regular session, duly assembled on the 13th day of November, 1995, the following budget amendment pursuant to Florida Statutes Chapter 129.06 (2) (d) be adopted:
