A RESOLUTION TO CHANGE THE FOLLOWING STREET NAMES IN THE CALLAHAN AREA. EVERYTHING WHICH IS SOUTH OF U.S. HIGHWAY 301 AND SOUTH OF STATE ROAD 200 AND INCLUDING PART OF THE TOWN OF CALLAHAN.
