

THEREFORE, LET IT BE RESOLVED; this 21st day of April 19 97, that the street currently known as **unnamed easement off Tomlinson Road** in Nassau County, Florida be hereafter referred to and known as **Family Lane** in Nassau County, Florida, and the County Engineer shall be authorized to erect any and all necessary signs indicating said name.

Thank You for your assistance and cooperation.

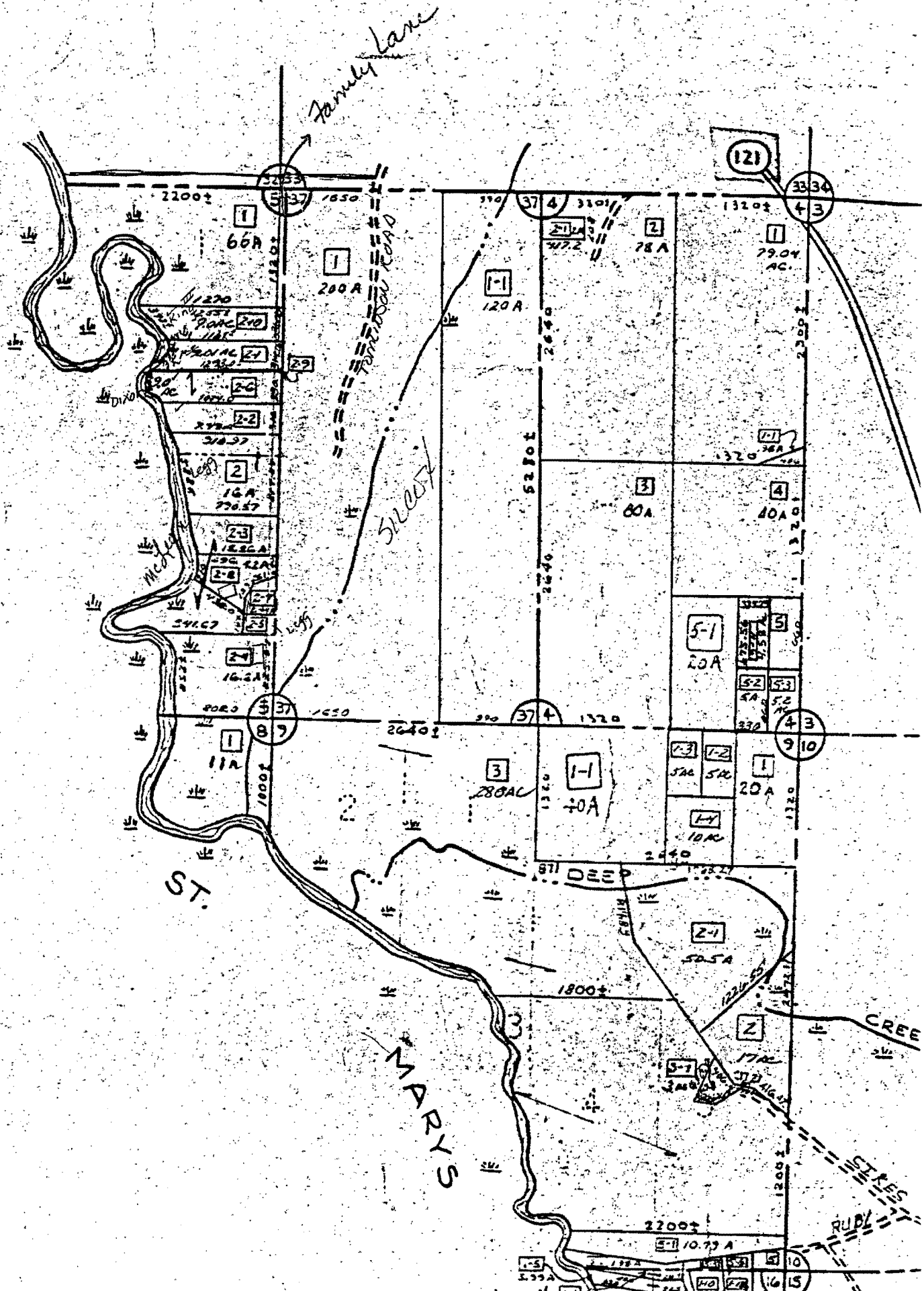

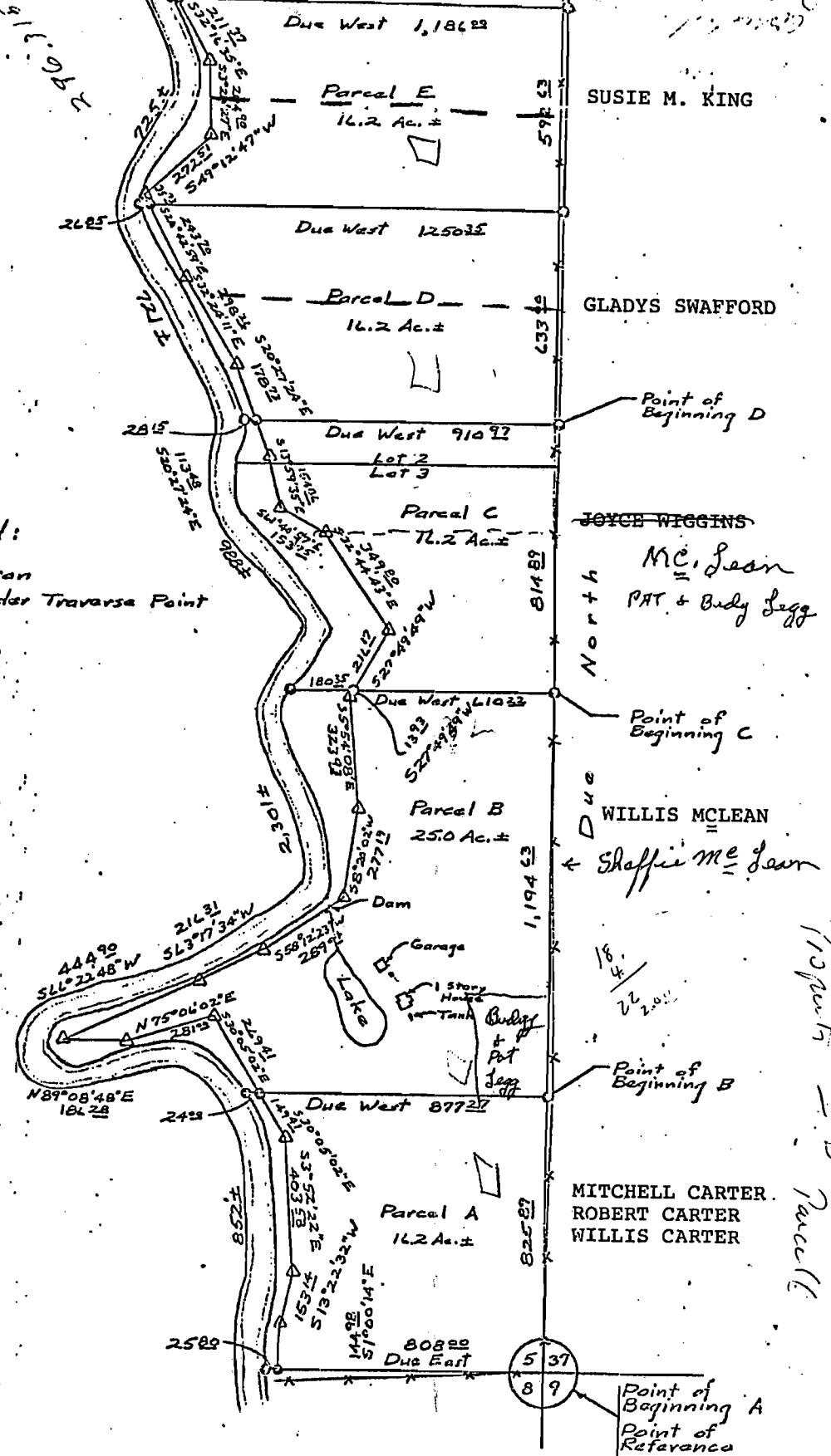
