WHEREAS, the majority of citizens of Nassau County currently residing on "unamed easement that extends off Tomlinson Road"; located in Section 05; Township 2N; Range 23E; have requested the street be named "Family Lane"; and

WHEREAS, the 911 Coordinator's office has reviewed the request in accordance with Ordinance Number 92-14, and has verified the request as acceptable and not in conflict with names already assigned, and

WHEREAS, the 911 Coordinator's office has forwarded the request to the Board of County Commissioners for consideration, now

THEREFORE, LET IT BE RESOLVED; this 21st day of April 19 97, that the street currently known as **unamed easement off Tomlinson** Road in Nassau County, Florida be hereafter referred to and known as Family Lane in Nassau County, Florida, and the County Engineer shall be authorized to erect any and all necessary signs indicating said name.
