
WHEREAS, the majority of citizens OF Nassau County currently residing on "**an unnamed easement which extends south off Old Baldwin Road**"; located in Section 36; Township 2N; Range 24E; have requested the street be named "**Whitetail Crossing**"; and

WHEREAS, the 911 Coordinator's Office has reviewed the request in accordance with Ordinance Number 92-14, and has verified the request as acceptable and not in conflict with names already assigned, and

WHEREAS, the 911 Coordinator's office has forwarded the request to the Board of County Commissioners for consideration, now

THEREFORE, LET IT BE RESOLVED; this 10thDay of November , 1997 , that the street currently known as **the unnamed easement which extends south off Old Baldwin Road** in Nassau County, Florida be hereafter referred to and known as **Whitetail Crossing** in Nassau County, Florida, and the County Engineer shall be authorized to erect any and all necessary signs indicating said name.

- 4) Foxridge Trail


