WHEREAS, Nassau County, Florida paid no consideration for said Warranty Deed, never took delivery of said Warranty Deed, and never recognized the purported conveyance thereunder; and

WHEREAS, Nassau County, Florida had no knowledge of the Warranty Deed being recorded of the legally described property as attached in Exhibit "A"; and

WHEREAS, Nassau County, Florida has never utilized the road right-of-way of the legally described property as attached in Exhibit "A"; and

WHEREAS, Nassau County, Florida has no intention of utilizing the road right-of-way as described in the attached Exhibit "A";, and

WHEREAS, Nassau County, Florida does not maintain nor has never maintained the road right-of-way as described in the attached Exhibit "A"; and

NOW, THEREFORE, BE IT RESOLVED, that the Nassau County Board of County Commissioners disclaims any interest in the legally described property as recorded in Official Records Book 0492, Page 0506, Nassau County, Florida.
