RESOLUTION NO. 98-194

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA DETERMINING THAT THE ACQUISITION OF PROPERTY OWNED BY CSX TRANSPORTATION, PARCEL NO. 30-2N-25-0000-0008-0000 BY CONDEMNATION IS NECESSARY AND SERVES A PUBLIC INTEREST

WHEREAS, the Board of County Commissioners has previously found that the re-construction of C.R. 108 is necessary for the benefit of the citizens of Nassau County; and

WHEREAS, the Board of County Commissioners retained the services of Reynolds, Smith & Hills, Inc. to design the road; and

WHEREAS, Reynolds, Smith & Hills, Inc. has provided the Board of County Commissioners with property descriptions that are necessary for the re-construction of the road; and

WHEREAS, the property is owned by CSX Transportation and is further described in Exhibit "A" and attached hereto and made a part hereof; and

WHEREAS, the Board of County Commissioners finds that the acquisition of the property is necessary for the road reconstruction and is in the best interest of the citizens of Nassau County; and

WHEREAS, the Director of Public Works has contacted the property owners and they have declined to convey the property to the county; and

WHEREAS, condemnation is the only means available to acquire the property.

NOW THEREFORE, BE IT RESOLVED this 28th day of December, 1998, by the Board of County Commissioners of Nassau County, Florida as follows:

- 1. The property owned by CSX Transportation is necessary for the reconstruction of C.R. 108.
- 2. It is in the best interest of the citizens of Nassau County that the property be acquired by condemnation.

- 3. The acquisition of the property serves a vital public interest.
- 4. The County Attorney is hereby authorized to proceed with the condemnation of the property at the earliest possible time.


