A RESOLUTION AMENDING RESOLUTION 2000 - 21, SPECIFICALLY AMENDING THE SCHEDULE OF FEES TO BE CHARGED BY THE PLANNING AND ZONING DEPARTMENT, NASSAU COUNTY, FOR REVIEW OF: ZONING, CONDITIONAL USE, VARIANCE, PLANNED UNIT DEVELOPMENT (PUD), DEVELOPMENT OF REGIONAL IMPACT (DRI), AND MISCELLANEOUS ITEMS

WHEREAS, the review of applications filed pursuant to the land development regulations of Nassau County require the establishment of fees and costs to be paid by said applicant; and

WHEREAS, due to the increased costs of review the Board of County Commissioners has found it necessary to amend Resolution 2000 - 21, adopting a schedule of fees; and


WHEREAS, the Board finds it is in the best interest of the citizens of Nassau County, Florida, to amend said Resolution.


