A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS HONORING THE VETERANS OF WORLD WAR II AND ENDORSING THE ESTABLISHMENT OF A MONUMENT IN WASHINGTON, D.C., FOR WORLD WAR II VETERANS.

WHEREAS, at a time of world crisis in 1941, the men and women of this country put their lives on the line to defeat tyranny and to defend freedom; and

WHEREAS, the men and women of our armed services displayed courage and valor across the bloodied landscape of Europe and the Pacific; and

WHEREAS, we owe so much to all who sacrificed for all of us, and we should always honor them forever; and

WHEREAS, a memorial is being established in Washington, D.C., to honor the men and women of World War II, and funds are being raised to support said memorial.

NOW, THEREFORE, BE IT RESOLVED this <u>20th</u> day of March, 2000, by the Board of County Commissioners of Nassau County, Florida, as follows:

1. The Board acknowledges all those during World War II who sacrificed for all of us, those who went to war or sent their husbands, wives, sons, and daughters to war for us, and those who never came back.

- The Board honors all Americans that fought, worked, and sacrificed to preserve our great Country and the world itself.

The Board endorses the long overdue memorial to all the men and women of World War II and urges every County, City, and citizen of the State of Florida to join in honoring all that they did by contributing monies to the memorial, and further, requests that all cities and counties adopt similar Resolutions.
