THENCE SOUTH 50° 30' 22" WEST, A DISTANCE OF 121.40 FEET TO A POINT ON THE SOUTHERLY RIGHT-OF-WAY LINE OF THE CSX RAILROAD (A 120.00 FOOT RIGHT-OF-WAY AS NOW ESTABLISHED) WITH THE NORTHWESTERLY RIGHT-OF-WAY LINE OF SCOTT ROAD (A 50.00 FOOT RIGHT-OF-WAY AS NOW ESTABLISHED);
