SEYMORE LANE

A PART OF THE SPANISH GRANT TO SAMUEL HARRISON OR SECTION 44, TOWNSHIP 2 NORTH, RANGE 28 EAST, NASSAU COUNTY, FLORIDA, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:
