ORDINANCE Α RESOLUTION PURSUANT TO 2002-31 SETTING FORTH REGULATIONS FOR THE ISSUANCE OF BEACH PERMIT STICKERS; PROVIDING FOR CONTROL AND PLACEMENT LOCATION OF SAID STICKERS; PROVIDING FOR ENFORCEMENT PROCEDURES; PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Ordinance 2002-31, this Resolution is enacted to provide for regulations for the issuance of beach permit stickers, provide for control and placement location of said stickers; provide for enforcement procedures; and provide for an effective date.

NOW, THEREFORE, BE IT RESOLVED this 20<sup>th</sup> day of May, 2002, by the Board of County Commissioners of Nassau County, Florida, as follows:

1. A vehicle permit shall be issued by the Clerk's office and other designated retail stores for beach driving privileges, upon presentation of a valid driver's license, receipt of a twenty-five dollar (\$25.00) fee, for out of County applicants, for an annual permit, and upon the acknowledgement by the applicant's signature, that they have received and read the rules stating what is expected of a person driving on the beach. Nassau County residents shall be exempt from the permit requirement. Nassau County residents shall produce a valid Florida Driver's License upon request of a certified law enforcement officer.

Daily vehicle permit(s) shall be issued by the 2. Clerk's office and other designated retail stores for nonresidents of Nassau County, upon presentation of a valid driver's license, receipt of a five-dollar (\$5.00) fee, for out of County residents, for a daily permit, and upon the receipt of the acknowledgement by the applicant's signature, that they have read the rules stating what is expected of a person driving on the beach. Nassau County residents shall be exempt from the daily permit fee.

3. The permits shall be available for sale to the public:

a. Monday through Friday at the Clerk's office during normal working hours.

b. Retail stores in Nassau County during their regular hours, including Saturday and Sunday.

4. All vehicle permits shall be permanently attached to the front windshield of the vehicle and is not transferable from one vehicle to another. The vehicle tag number shall be recorded on the permit.

5. The Clerk shall promulgate accounting and control procedures for the permits and shall be responsible for the control, distribution, and accountability of the beach permit stickers. Each retail outlet that sells permits shall be bound by these requirements, and the requirements

set forth herein and those set forth in Ordinance 2002-31. Failure to abide by the Ordinance, Resolution, and/or Clerk's procedures shall cause the Board of County Commissioners to revoke the retail outlet's privilege to sell said permits. The length of the revocation shall be determined by the Board of County Commissioners and shall be considered at a regularly scheduled meeting with notice to the retail store.

6. The Clerk's office and each retail outlet shall be entitled to collect, from the sale of each permit, an amount up to two dollar (\$2.00) for each permit. Said charge shall be a handling charge and shall be deducted from the twenty-five dollar (\$25.00) or five dollar (\$5.00) amount of each permit that is paid to the County. No retail outlet shall charge an amount higher than twentyfive dollars (\$25.00) for seasonal permits or five dollars (\$5.00) for daily permits. Any retail outlet charging more than twenty-five dollars (\$25.00) or five dollars (\$5.00) per permit shall forfeit the privilege of selling said permits.

7. The rules and regulations set forth in the attached Exhibit "A" are applicable, and a copy shall be given to each person receiving a permit, and they shall

sign acknowledging receipt and understanding of the rules and regulations.

8. This Resolution shall become effective upon its being approved by the Board of County Commissioners.

## EXHIBIT "A" RULES AND REGULATIONS FOR DRIVING OR PARKING ON THE BEACHES IN THE UNINCORPORATED AREAS OF NASSAU COUNTY

- 1. A violation of any portion of Ordinance 2002-31 and/or this Resolution shall, upon conviction in the County Court, subject the violator to the fine/incarceration set forth in Section 14 of Ordinance 2002-31.
- 2. Maximum speed limit is ten (10) miles per hour (mph).
- 3. Driving in the dunes and area(s) of native stabilizing vegetation of the dune system is prohibited.
- 4. Sunbathers and pedestrians also utilize the beach and have the right-of-way, and extreme caution must be exercised when driving on the beach.
- 5. Drive on hard surfaces when attainable.
- 6. Signage on the beach indicates areas where it is permissible to drive and/or park. You cannot drive or park except as indicated by the signage.
- 7. Dogs must be under the control of owner.
- 8. Littering is prohibited.

- 9. No consumption of alcoholic or intoxicating beverages while in a motor vehicle or on the beach itself.
- 10. No possession of unsealed containers of alcoholic or intoxicating beverages in the vehicle or on the beach itself.
- 11. Four-wheelers and all terrain vehicles (ATV's), except for official-use only vehicles as approved by the Board of County Commissioners and designated accordingly by the Board, are prohibited on the county's beach areas.
- 12. The effective date of the beach permit requirements shall be thirty (30) days from May 20, 2002.

WARNING: Failure to adhere to these Rules and Regulations may result in arrest, and if convicted, a maximum fine of \$500.00 and/or up to ten (10) days in jail.
