

RESOLUTION 2002 - 202

A RESOLUTION APPROVING RENTAL RATES FOR THE USE OF NASSAU COUNTY FACILITIES FOR NASSAU COUNTY RESIDENTS AND FOR OUT-OF-COUNTY RESIDENTS; APPROVING THE MAINTENANCE DEPARTMENT AS THE ENTITY TO ADDRESS ANY CONFLICTS BETWEEN PERSONS RENTING THE COUNTY FACILITIES; AND APPROVING THE MAINTENANCE PERSON IN CHARGE TO DETERMINE WHETHER THE BUILDING IS PROPERLY CLEANED; AND AUTHORIZING THE MEMBERS OF THE BOARD OF COUNTY COMMISSIONERS OR THE COUNTY COORDINATOR TO WAIVE THE RENTAL FEE FOR COUNTY FACILITIES WHEN THE EVENT DATE WOULD OCCUR PRIOR TO THE NEXT REGULARLY SCHEDULED BOARD MEETING.

WHEREAS, the Board of County Commissioners approved by motion on October 16, 2000, the rental fee schedule for the use of County facilities for Nassau County residents and for out-of-County residents; and

WHEREAS, the Board of County Commissioners approved by motion on May 14, 2001, the Maintenance Department as the entity that would address any conflicts between persons renting the County buildings, and the Maintenance Department person in charge to determine whether the building is properly cleaned; and

WHEREAS, the Board of County Commissioners, by motion on November 18, 2002, approved the authority of the members of the Board of County Commissioners or the County Coordinator to waive the rental fee for County buildings when the event date would occur prior to the next regularly scheduled Board of County Commissioners' meeting.

NOW, THEREFORE, BE IT RESOLVED this 9th day of December, 2002, by the Board of County Commissioners of Nassau County, Florida, as follows:

1. The Board of County Commissioners unanimously approves the following fee schedule of rental amounts for the use of County facilities by Nassau County residents and by out-of-County residents:


FEE SCHEDULE FOR BALL PARKS (RESIDENT AND OUT-OF-COUNTY) :

Soccer Field	\$100.00 per field (unmarked) \$125.00 deposit


2. The Board of County Commissioners further approves the Maintenance Department as the entity that addresses any conflicts between persons renting County facilities, and the Maintenance Department person in charge to determine if the facility is properly cleaned.

3. The Board of County Commissioners further authorizes that, pursuant to a request of a member of the Board of County Commissioners, the County Coordinator may waive the rental fee for County facilities when the event date would occur prior to the next regularly scheduled Board of County Commissioners' meeting.


