A RESOLUTION OF THE BOARD OF COUNTY COMISSIONERS OF NASSAU COUNTY, FLORIDA, AMENDING AND SUPPLEMENTING A RESOLUTION ENTITLED "A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA AMENDING AND RESTATING IN ITS ENTIRETY ITS RESOLUTION ADOPTED DECEMBER 22,2003 WITH RESPECT TO THE COUNTY'S SPECIAL ASSESSMENT BONDS, SERIES 2004; AND PROVIDING AN EFFECTIVE DATE;" MODIFYING THE INITIAL PRINCIPAL PAYMENT DATE WITH RESPECT TO SAID BONDS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Nassau County, Florida (the "County") has previously adopted Resolution No. 2004-79 (the "Bond Resolution"), authorizing the issuance of the County's Special Assessment Bond, Series 2004 (the "Bond"); and

WHEREAS, the County and the Bondholder desire to modify the initial payment date with respect to said Bond;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA as follows:

SECTION 1. The Bond Resolution is hereby amended to provide that the initial payment date for payment of principal on the Bond shall be July 1, 2005, and all amounts otherwise to have been paid on October 1, 2005 (including accrued interest to such date) shall instead be paid on July 1, 2005 and no October 1, 2005 payment shall be required to be made. All payment dates for years subsequent to 2005 shall remain as set forth in the Bond. The Chairman and Clerk are hereby authorized to execute and deliver to the Bondholder a revised Bond reflecting the above-referenced modifications, in exchange for the existing Bond currently held by the Bondholder.

SECTION 2. Except as otherwise amended hereby, the Bond Resolution shall remain in full force and effect.

SECTION 3. This supplemental resolution shall take effect immediately upon its adoption.

The interest rate on this Bond is subject to adjustment upon a Determination of Taxability (as defined in the Resolution) and certain other events affecting the tax status of the Issuer and the registered owner hereof, all as set forth in the Resolution defined below.
