Pickett, Jr., Cathy Robinson-Pickett, Patricia Pickett Jones, and Donna Pickett Dubberly, owners, and Patricia Pickett Jones, agent for owners, a public hearing was held at 7:00 PM on the 28 th day of August, 2006, at the Commission Chambers at the Nassau County Governmental Complex, located at 96135 Nassau Place, Yulee, Florida, pursuant to a notice duly published as provided by law for consideration by the Board of County Commissioners to close, vacate, and abandon the roadways or alleyways hereinafter described and to renounce and disclaim the right of the public and the county in and to said roadways and alleyways described as follows:
