

RESOLUTION 2006 - 14

A RESOLUTION AMENDING RESOLUTION 96-185, WHICH SET FORTH REGULATIONS FOR PERMITS ISSUED FOR TRAILERS AND OTHER CONVEYANCES THAT CARRY HORSES, PONIES, BURROS OR ANY OTHER ANIMAL OF AN EQUINE NATURE ONTO PETERS POINT PARK.

WHEREAS, the Board of County Commissioners adopted Resolution 96-185 on September 9, 1996; and

WHEREAS, the Board has found it necessary to amend Resolution 96-185.

NOW, THEREFORE, BE IT RESOLVED this 13th day of February, 2006, by the Board of County Commissioners of Nassau County, Florida, that Resolution 96-185 is hereby amended as follows:

1. This Resolution sets forth regulations and requirements for the issuance of decals for trailers and other conveyances that carry horses, ponies, burros and any other animal of an equine nature at Peters Point Park.

2. The County ~~Coordinator~~ Administrator or his designee shall issue decals. Said decals may be applied for and picked up at the Nassau County Building Department located at 96161 Nassau Place, Yulee, Florida. Said decals shall be of a certain color as prescribed by the County ~~Coordinator~~ Administrator and contain numbers and shall be affixed to the trailer and/or conveyance.

3. The decals shall be affixed to the trailer or conveyance as to be clearly visible.

4. The decal shall be effective for the fiscal year in which it is issued (October 1 through September 30).

5. The fee for each decal shall be \$20.00 per year for out of County residents. There shall be no fee for the decal for Nassau County residents.

6. The trailers or conveyances shall only be parked within designated areas at Peters Point Park.

7. To obtain a decal, the following information must be provided:

a. Name and address and phone number.

b. Copy of valid Florida or other jurisdictional driver's license.

c. Registration of the vehicle or trailer.

d. Execution of a sworn affidavit that the trailer or conveyance is not for the commercial utilization of the horses, ponies, burros, or any other animal of an equine nature.

8. No more than two (2) decals per applicant shall be issued.

9. Decals shall be issued for personal non-commercial use only.


10. Horses, ponies, burros and any other animal of an equine nature shall not be offloaded from the trailer or conveyance except in the designated parking area within Peters Point Park.

11. The trailer or conveyance shall be maintained in a sanitary manner.



12. The horses, ponies, burros or any other animal of an equine nature, after being unloaded, shall be walked from the Peters Point Park.

13. Failure to adhere to the rules and regulations set forth herein shall result in revocation of the permit(s).


