A RESOLUTION URGING THE UNITED STATES CONGRESS AND THE FLORIDA LEGISLATURE TO VOTE AGAINST ANY VIDEO FRANCHISING REFORM LEGISLATION THAT EITHER WEAKENS COUNTY'S AUTHORITY TO ENTER LOCAL FRANCHISE AGREEMENTS WITH CABLE COMPANIES OR TELEPHONE COMPANIES THAT OFFER VIDEO SERVICES OR ALLOWS FOR STATE-WIDE OR NATION-WIDE VIDEO FRANCHISE AGREEMENTS THAT DO NOT PROVIDE ADEQUATE PUBLIC, SUPPORT FOR LOCAL EDUCATIONAL, GOVERNMENTAL ACCESS CHANNELS; PROVIDE THE COUNTY SUFFICIENT AUTHORITY TO MAINTAIN RIGHTS-OF-WAY; ENFORCE "BUILD-OUT" REQUIREMENTS; AND PREVENT REDLINING OR DISCRIMINATELY OFFERING VIDEO SERVICES; REQUEST THAT ALL MEMBERS OF THE NORTH FLORIDA CONGRESSIONAL DELEGATION AND NORTH FLORIDA STATE LEGISLATIVE DELEGATION ACTIVELY OPPOSE SUCH LEGISLATION; PROVIDING AN EFFECTIVE DATE.

WHEREAS, video service franchising includes franchises with cable companies and phone companies offering cable-like services; and

WHEREAS, several Bills involving video service franchising reform have been proposed in Washington, D.C., and Tallahassee, Florida; and

WHEREAS, the County believes that providing a level playing field in the video service market will allow for more competition and better services to citizens of the County; and

WHEREAS, maintaining local franchising authority over cable companies and phone companies offering cable-like video services is the best means for providing support for

adequate local public, educational, and governmental access channels; provide the County with sufficient authority to maintain public rights-of-way; allow the County to enforce "build-out" requirements; and prevent video services providers from redlining or discriminately offering video services; and

WHEREAS, maintaining local franchising authority over video services and providing a level playing field in the video service market are not only compatible, but also the best alternative for providing video services and protecting the citizens of the County.

NOW, THEREFORE, BE IT RESOLVED this ____10th day of April, 2006, by the Board of County Commissioners of Nassau County, Florida, as follows:

1. The County opposes and urges the United States Congress and the Florida Legislature to vote against any video franchising reform legislation that weakens local governments' authority to enter into local franchise agreements with cable companies or telephone companies that offer video services; and requests that all members of the North Florida Congressional Delegation and the North Florida State Legislative Delegation actively oppose such legislation.

The County opposes and urges the United States Congress and the Florida Legislature to vote against any video franchising reform legislation that weakens local governments' authority to (1) ensure adequate support for local public, educational, and governmental access channels; (2) maintain public rights-of-way; (3) enforce "build-out" requirements; and (4) prevent video services providers from redlining or discriminately offering video services; and requests that all members of the North Florida Congressional Delegation and the North Florida State Legislative Delegation actively oppose such legislation.
