#### RESOLUTION NO. 2007- 138

A RESOLUTION OF THE BOARD OF COUNTY COMMISIONERS OF NASSAU COUNTY, STATE OF FLORIDA, RENOUNCING AND DISCLAIMING ANY RIGHT OF NASSAU COUNTY, FLORIDA, AND THE PUBLIC IN THE ROAD RIGHT OF WAY AND DRAINAGE EASEMENTS AND UNOBSTRUCTED DRAINAGE EASEMENTS, PURSUANT TO SECTION 336.125, FLORIDA STATUTES AND CONVEYANCE OF SAID LANDS TO BLACKROCK HAMMOCK HOMEOWNERS ASSOCIATION.

WHEREAS, pursuant to section 336.125 Florida Statutes, the Board of County Commissioners of Nassau County, Florida ("the Board") held a public hearing on July <u>23rd</u>, 2007, during which the Board considered a requested abandonment of public roads in the Blackrock Hammock Subdivision, as more particularly described as follows:

WHEREAS, the Home Owners Association has requested the abandonment and conveyance of the roadway in writing for the purpose of converting the subdivision to a gated neighborhood with restricted public access; and

WHEREAS, no fewer than 4/5 of the owners of record of property located in the subdivision have consented in writing to the abandonment and simultaneous conveyance by Nassau County of the roadways to the Home Owners Association; and

WHEREAS, Home Owners Association has provided a certificate from the Secretary of State showing it is both a corporation not for profit organization and in good standing under Chapter 617 Florida Statutes; and

WHEREAS, the Home Owners Association has attached to its request of abandonment, a First Amendment to the Declaration of Covenants, Conditions, Restrictions and Easements ("the Declaration") for Blackrock Hammock, which amendment grants the power to levy and collect assessments for routine and periodic major maintenance and operation of drainage facilities and pavement in the subdivision; and

WHEREAS, the Amendment to the Declaration, provides the

Home Owners Association with authorization to enter into and execute such agreements, covenants, warranties, and other instruments as required by Nassau County; and

WHEREAS, the Home Owners Association has provided assurance that funds, reserved funds, and funding sources shall be available for reconstruction or replacement of the roads and drainage facilities in the subdivision after abandonment by the county; and

WHEREAS, the Homeowners Association has agreed to enter into such agreement as shall be required by the county setting forth requirements and conditions with respect to the ongoing, maintenance, repair and the periodic reconstruction of replacement of roads and drainage facilities, in the subdivision after abandonment; and

WHEREAS, the Board has determined it is in the best interest of Nassau County and the public that said roadways and associated drainage facilities be abandoned by Nassau County and conveyed to the Blackrock Hammock Homeowner Association, Inc., by the County.

NOW, THEREFORE, BE IT RESOLVED this <u>23rd</u> day of July, 2007 by the Board of County Commissioners of Nassau County, Florida, in a public meeting duly constituted that the County hereby consents to and does abandon the roads and associated drainage facilities as described above in Exhibit "A", and conveys said roads to the Blackrock Hammock Homeowners Association, upon its entering into such agreements, covenants, warranties and other written instruments, in regards to setting forth the requirements and conditions with respect to ongoing maintenance, repair and periodic reconstruction of replacement of roads and drainage facilities in the subdivision after abandonment.

BE IT FURTHER RESOLVED that the Clerk of this Board shall cause to be published, within thirty (30) days after the adoption of this Resolution, in one issue of the <u>News Leader</u>, a notice of the adoption of this Resolution abandoning all of those certain roadways, and drainage easements and unobstructed drainage easements as hereinbefore described in the preamble hereto, and the renouncing and disclaiming of any right or interest of the County and the public in said roadways, and drainage easements and unobstructed drainage easements.

NOTICE IS HEREBY GIVEN that the Board of County Commissioners of Nassau County, Florida, did on the <u>23rd</u> day of July, 2007 adopt a resolution abandoning those certain roadways, drainage easements and unobstructed drainage easements described as follows: See Legal Description attached hereto as Exhibit "A".


