

RESOLUTION NO. 2007 -167

A RESOLUTION RENEWING A TIPPING FEE FOR CERTAIN CLASSIFICATIONS OF WASTE MATERIALS AT THE WEST NASSAU LANDFILL

WHEREAS, Ordinance No. 91-17, as amended, provides for the imposition of tipping fees for the various classifications of waste materials; and

WHEREAS, the Board of County Commissioners of Nassau County, Florida, finds it in the best interest of the citizens of Nassau County to re-set the current fees for certain classifications of waste materials.

NOW, THEREFORE BE IT RESOLVED this 17th day of September, 2007 by the Board of County Commissioners of Nassau County, Florida, as follows:

1. The tipping fee for tires shall be charged as follows:

First four passenger tires from each Nassau County household	FREE
Passenger car/pickup truck tires (max size P265/75R16)	\$7.00 Each
All other tires	\$200/ton

2. The tipping fee for separated yard waste shall be as follows:

Yard Waste/Land Clearing material	\$30/ton
Yard Waste from Nassau County residence hauled by resident	FREE

3. The surcharge for White Goods shall be as follows: One (1) appliance/year free; and \$5.00 each thereafter.

4. The tipping fee for friable asbestos in the amount of Thirty Dollars (\$30.00) per yard and a set up fee of One Hundred Dollars (\$100.00) per load shall remain the same.

5. The tipping fee for in-county construction debris shall be \$30.00 per ton.

6. The tipping fee for in-county industrial waste (sludge, etc.) shall be \$30.00 per ton.


7. The fees set forth in this Resolution shall become effective October 1, 2007.



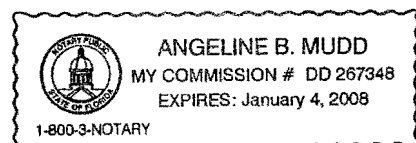

Friable Asbestos	\$30.00 per yard
Asbestos Set-up Fee	\$100.00
