# Assessment of Objectives & Policies

# Summary

Part 4 provides an assessment of key objectives and policies in each of the nine (9) elements of the County's Comprehensive Plan and how they relate to the ten (10) major issues. Each assessment includes a statement as to whether the objective or policy has been implemented; it's effectiveness, and whether it should be kept unchanged, revised in some way, or should be removed from the plan. The assessment may also include recommended action to implement the policy if it has not been fully implemented. It also will list which of the ten major local issues are affected by the objective or policy.

Part 4 is not a comprehensive assessment of all objectives and policies in the Plan. It includes only those objectives and policies that were felt to have a direct impact on one or more of the ten identified major local issues.

In the case of policies that are extremely long and complex (Future Land Use Policy 1.02.05, for example), the full text of the policy has been abbreviated in Part 4 for the convenience of the reader. The text of these policies can be found in their entirety in Appendix F.

# **Future Land Use Element**

# <u>Overview</u>

Growth that is planned for and anticipated occurs in a much more efficient and orderly manner. Parts of Nassau County experienced rapid growth prior to the 1985 Growth Management Act, which mandated that local governments plan for and regulate growth. The result of this haphazard growth is sprawling development and the proliferation of commercial "strips". This pattern results in inefficient service delivery, but also provides valuable lessons for future development. A key lesson that has been learned is the need for a collection of principles that can guide future policy decisions; in essence, a policy "toolbox".

The 2010 Comprehensive Plan was the toolbox that Nassau County looked to for shaping its future. The Future Land Use Element is a key part of the growth management toolbox that is supposed to provide specific criteria for future development in Nassau County. The Nassau County Growth Management Department is the administrative entity that administers the goals, objectives and policies (GOPs) of the Future Land Use Element. The county monitors the application of these objectives and policies on an ongoing basis, and makes text amendments as part of the semi-annual amendment process as needed to reflect changing conditions.

More specificity would be a benefit to most policies in this element. The objectives and policies of the Future Land Use Element should also be updated to reflect the new planning horizon to 2030. They should be unified toward a shared vision for the continuing development of the County.

### Objective 1.01

"Upon adoption of the EAR based Plan amendment, the County will correlate future land uses with the appropriate environmental conditions and the availability of supporting infrastructure."

Assessment: This Objective has not been fully met. The following actions are recommended:

- See recommendations to policies linked to this objective below.
- The objective should be revised to read as follows: "The County will correlate future land uses with the appropriate environmental conditions and the availability of supporting infrastructure."

# Major Local Issues:

- Issue 1- Update the future land use plan
- Issue 5- Preserve rural lifestyle choices

Policy 1.01.01

"Protect estuaries by mitigating the harmful effects of sanitary sewer wastewater and stormwater discharge into Class II and Class III waters by implementing the policies of this comprehensive Plan, which include, but are not limited to, initiating a countywide storm water management plan, requiring the use of best management practices for silviculture requiring the provision of natural vegetated upland buffers between developed areas and wetlands and water bodies as established in Policy 1.04A.02, and establishing criteria for reuse as cited in Policy 1.04A.07."

**Assessment:** This Policy has not been fully implemented. The County initially intended to implement this policy with a 50 foot wetland buffer; this was amended in 2006 to mirror the 25 foot average buffer prescribed by Rule 62-345,FAC and administrated by the SJRWMD. The following actions are recommended:

- Refer to recommendations for Policy 1.02.05. regarding definition of conservation and limited development overlays.
- Place greater emphasis on the uses within the buffer instead of the width.

### Policy 1.01.02

"Criteria shall be included in the Land Development Regulations to include requirements to preserve/replace the natural/native vegetation along perennial streams and waterways as defined in best management practices for silviculture to maintain the natural beauty of the area, to control erosion, and to retard runoff."

**Assessment:** This Policy has not been fully implemented. The following actions are recommended:

Include definitions of perennial streams and waterways. Include map of same in Plan.

Issue 6- Preserve environmental resources

### Policy 1.01.03

"Protect natural resources by working closely with various local, state, and federal agencies in collecting information, coordinating development permitting and reporting violations of laws and regulations, which would have a negative impact on the environment."

Assessment: Efforts to implement this Policy are ongoing; no changes are required.

# Policy 1.01.07

"This policy addresses development standards within the 100-year floodplain. The land use designation of the 100-year floodplain is Conservation III (as per Policy of this Plan). The Conservation III land use designation is an overlay zone. Development within Conservation III areas (e.g., the 100 year flood plain) may develop as allowed by the underlying land use, unless otherwise restricted by the policies of this Comprehensive Plan and the County's Flood Plain Ordinance. Nassau County shall include controls in its

Land Development Regulations based upon the latest version of the Flood Insurance Rate Maps and model "Flood Damage Prevention Ordinance" promulgated by FEMA to establish the location of the 100-year floodplain and flood prone areas in Nassau County. The LDRs, then, shall require new construction in these areas to meet FEMA regulations. Our policy will be to control development in flood prone areas to match FEMA requirements to qualify for community rating system. In addition, the following criteria will apply to development in the 100-year floodplain.....(see Appendix F)"

Assessment: This Policy has been implemented, but needs to be updated or revised as follows:

- Refer to recommendations for Policy 1.02.05. regarding definition of conservation and limited development overlays.
- The County's flood damage protection ordinance codifys the FEMA requirements, there is no need to repeat them in the Comprehensive Plan.

Issue 6- Preserve environmental resources

# Objective 1.02

"Upon Plan adoption, the County will locate future land uses where they appear most compatible with surrounding land uses and will establish the following policies to implement the redevelopment and renewal of blighted areas."

Assessment: This Objective has been met, but needs to be updated or revised as follows:

- See recommendations to policies linked to this objective below.
- The objective should be revised to read as follows: "The County will locate future land uses where they appear most compatible with surrounding land uses and will establish the to encourage the redevelopment and renewal of blighted areas."

### Major Local Issues:

Issue 1- Update the future land use plan

## Policy 1.02.01

"Future industrial development shall be located in planned industrial parks or in areas with compatible surrounding land uses."

**Assessment:** This Policy has not been fully implemented. The following actions are recommended:

- Include new industrial/office business park land use category (see recommendations for 1.02.05).
- Include policies to coordinate with local economic development entities to find appropriate locations for industry.
- Include policies limiting amendments on industrial designations on FLUM.

- Issue 3- Promote economic development
- Issue 4- Protect and expand land designated for job-generating land uses

# Policy 1.02.02

"The Land Development Regulations will include criteria to reduce the intrusion of incompatible commercial, industrial and other land uses into residential areas."

**Assessment:** This Policy has not been fully implemented. The following actions are recommended:

- Refer to recommendations for Policy 1.02.05. regarding review of FLUM categories and encouraging efficient development patterns.
- Review and refine incompatible use buffers in LDRs.

# Major Local Issues:

- Issue 1- Update the future land use plan
- Issue 3- Promote economic development
- Issue 4- Protect and expand land designated for job-generating land uses

# Policy 1.02.03

"Permit future development to proceed only in accordance with land uses designated on the Future Land Use Map."

**Assessment:** Efforts to implement this Policy are ongoing; no changes are required. This is a requirement of Ch. 163, F.S.. Affected citizens are afforded standing to enforce it.

### Major Local Issues:

Issue 1- Update the future land use plan

# Policy 1.02.04

"Promote the clustering of planned commercial land uses through incentives and regulations such as density bonuses and improved access."

**Assessment:** This Policy has not been fully implemented. The following actions are recommended:

- Density bonuses are not applicable to commercial development. Remove reference from policy.
- Incentives should include identification of strategic commercial nodes and mixed use developments.

Issue 1- Update the future land use plan

# Policy 1.02.05

"Land Development Regulations adopted to implement this Plan shall be based upon the land use standards described below and spatially displayed on the Future Land Use Map....(see Appendix F)"

Assessment: This Policy has been implemented, but needs to be updated or revised as follows:

- Review FLUM land use categories and amend them if necessary to ensure that they promote efficient development patterns.
- Provide effective and measurable density and intensity standards.
- Establish specific criteria for changes in land use.
- · Create a new industrial/office business park land use category
- Include water-dependent commercial/industrial land use category
- Remove wetlands (Conservation I & II) as a separate land use category on the FLUM.
- Incorporate the appropriately defined criteria into the land development code.

Issue 1- Update the future land use plan

# Objective 1.03

"Upon Plan adoption, the County shall implement the following policies to eliminate or reduce land uses inconsistent with the County's character and the Future Land Use Map."

Assessment: This Objective has not been fully met. The following actions are recommended:

- See recommendations to policies linked to this objective below.
- Clarify what is meant by County character
- Link Objective to property rights protection per Objective 1.09

# Major Local Issues:

Issue 1- Update the future land use plan

# Policy 1.03.01

"Land Development Regulations shall be adopted which set standards for buffering and separation between land uses of different densities or intensity of use so as to minimize interference between uses."

**Assessment:** This Policy has not been fully implemented. The following actions are recommended:

- Refer to recommendations for Policy 1.02.05. regarding review of FLUM categories and encouraging efficient development patterns..
- Review and refine incompatible use buffers in LDRs.

# Major Local Issues:

Issue 1- Update the future land use plan

# Policy 1.03.02

"The County Building Official annually shall review the condition of structures that are suspected to be substandard and when found to be deficient, require that they be brought into compliance with adopted building codes."

Assessment: This Policy has been implemented, but needs to be updated or revised as follows:

This policy is not related to this objective. Move to Housing element under Objective 3.02

# Major Local Issues:

Issue 1- Update the future land use plan

### Policy 1.03.03

"Land Development Regulations shall provide density bonus incentives to direct commercial and multi-family into "cluster" development patterns, thereby, eliminating or reducing strip or ribbon development, which follows major County or state roads."

**Assessment:** This Policy has not been fully implemented. The following actions are recommended:

Define and adopt bonuses and other incentives into LDRs as required by this policy.

 Establish clear criteria for affordable housing and performance standards for implementation.

# Major Local Issues:

Issue 1- Update the future land use plan

### Policy 1.03.04

"The County shall adopt and implement land use controls such as minimum set-back and property access points adjacent to major roadways in order to minimize hazardous traffic conditions and maximize traffic flow."

Assessment: This Policy has been implemented, but needs to be updated or revised as follows:

- This policy is not related to this objective. Move to a more appropriate place in the Plan or remove policy if found to be redundant.
- Incorporate FDOT access control standards

Issue 1- Update the future land use plan

# Policy 1.03.05

"Land Development Regulations will be amended to provide language that discourages Future Land Use Map changes that increase density."

**Assessment:** This Policy has not been fully implemented. The following actions are recommended:

- Policy is too broad. Increased density is appropriate in many areas.
- Refer to recommendations for Policy 1.02.05 regarding review of FLUM categories and encouraging efficient development patterns.

## **Major Local Issues:**

Issue 1- Update the future land use plan

### Objective 1.04A

"Upon Plan adoption, the county shall take positive action to protect natural resources through implementation of the following policies:"

Assessment: This Objective has been met, but needs to be updated or revised as follows:

- See recommendations to policies linked to this objective below.
- Require environmental assessment early in the development review process
- Create policies for avoidance and minimalization of environmental damage while allowing continued development.

### Major Local Issues:

Issue 6- Preserve environmental resources

### Policy 1.04A.01

"Nassau County shall assume an active role in protecting the integrity of agricultural land by enforcing Future Land Use Element Policies regarding agricultural land use densities."

Assessment: This Policy has been implemented, but needs to be updated or revised as follows:

- Define "active role".
- Refer to recommendations for Policy 1.02.05 for AG land use categories.
- This statement is redundant, define what actions will be taken to protect agriculture.

- Issue 1- Update the future land use plan
- Issue 5- Preserve rural lifestyle choices
- Issue 6- Preserve environmental resources

### Policy 1.04A.02

"The County shall restrict development in conservation areas to the maximum extent possible short of a "taking". Development in Conservation (Limited Development) will be permitted at a density no greater than 1 unit per 5 acres with permitted density clustered on the upland portion of the parcel or on that part of the parcel or on that part of the parcel that will least environmentally affected by construction/development. Where the Future Land Use Map identifies an underlying land use of less density, the density of the underlying land use will prevail. Development will be prohibited in areas designated as Conservation-Preservation (Policy 1.02.05.I-J)... (see Appendix F\_)"

Assessment: This Policy has been implemented, but needs to be updated or revised as follows:

 Refer to recommendations for Policy 1.02.05 regarding definition of conservation and limited development overlays.

### Major Local Issues:

- Issue 1- Update the future land use plan
- Issue 5- Preserve rural lifestyle choices
- Issue 6- Preserve environmental resources

# **Policy 1.04A.02A**

"The County shall not approve any plats that create lots that are not developable due to wetland constraints."

**Assessment:** Efforts to implement this Policy are ongoing; wetland limitations should also be assessed in non-residential and rural subdivisions.

### Major Local Issues:

Issue 6- Preserve environmental resources

### **Policy 1.04A.02B**

"An owner of an existing undevelopable wetland parcel that also owns an adjacent nonwetland parcel shall be required to combine the two parcels for development purposes so that the proposed development can be designed according to wetland protection policies of this Comprehensive Plan."

Assessment: Efforts to implement this Policy are ongoing; no changes are required.

### Major Local Issues:

Issue 6- Preserve environmental resources

# Policy 1.04A.03A

"In order to maintain the overall ecological integrity of the wetlands community, silviculture activities shall follow the best management practices outlined in the publications titled Silvaculture Best Practices Handbook (Revised May 1993, Florida Department of Agriculture and Consumer Services, Division of Forestry)."

Assessment: Efforts to implement this Policy are ongoing; no changes are required.

Issue 6- Preserve environmental resources

# Policy 1.04A.03B

"The silviculture policies of this plan are consistent with the 1993 edition of the Florida Department of Agriculture and Consumer Services, Best Management Practices Handbook. As new editions of the Handbook are published, this plan will be reviewed to ensure that it remains consistent with each new edition."

**Assessment:** Efforts to implement this Policy are ongoing; no changes are required. Future changes will be coordinated with the Division of Forestry.

# Major Local Issues:

Issue 6- Preserve environmental resources

### Policy 1.04A.04

"The County shall require that the quantity of stormwater runoff after development be equal or less than that which occurred prior to development."

**Assessment:** Efforts to implement this Policy are ongoing; This occasionally creates greater storage than required by SJRWMD, which may not be appropriate in some cases.

### Major Local Issues:

Issue 6- Preserve environmental resources

### Policy 1.04A.05

"The County shall require that wastewater be reused where practical. New wastewater treatment plants shall be required to provide for the reuse and/or disposal of wastewater by best available technology, including agricultural or landscaping irrigation, percolation, or other permitted measures unless data are presented to support claims that such reuse will impact an unreasonable economic or engineering demand on the plant ownership."

**Assessment:** Efforts to meet this Objective are ongoing; no changes are required. Planning for the required use of treated effluent in the future should be increased.

### Major Local Issues:

Issue 6- Preserve environmental resources

# Policy 1.04A.06

"The County shall control the number of septic tanks sited in environmentally sensitive areas through permitting only the units approved by the County Health Department based upon their determination of the soils' ability to function as an acceptable drain field. Explore and establish a timetable or plan to extend public sewer lines where feasible to environmentally sensitive areas where population justifies it."

Assessment: This Policy has been implemented, but needs to be updated or revised as follows:

- Define "environmentally sensitive areas" or remove from policy.
- Sewer service plan should be a separate policy and be coordinated with utility providers.
- Coordinate with the Health Dept. to consider wetland setbacks and net lot size criteria to be included in the LDC.

### Major Local Issues:

Issue 6- Preserve environmental resources

### Policy 1.04A.07

"The County shall regulate mining operations as follows. Mining shall be permitted only in Agricultural (up to 5 acres) and Industrial Land Use (5 acres or more). No mining operations including petroleum, natural gas, and liquid natural gas drilling shall be permitted within 200 feet of a property line. Mining operations impacting 5 or more acres of surface area will be regulated through LDRs to restrict the extent of borrow pits and dredge and fill activities to within 200 feet of property lines or wetland boundaries and to a depth not to exceed the top layer of overlying strata protecting potable water aquifers."

**Assessment:** Efforts to implement this Policy are ongoing; Additional criteria regarding the impacts to transportation infrastructure and the water supply should be considered.

#### Major Local Issues:

Issue 6- Preserve environmental resources

### Policy 1.04A.07A

"Impacts from mining operations within the County's forested wetlands shall be minimized, through avoidance of disruption of occupied endangered or threatened species habitat or through requiring restoration of similar habitat when mining is approved in forested wetland. Mining operations and restoration of mined areas must meet the standards of Rule 62C-16.0051 FAC. For mining in wetlands, these standards include 62C-16.0051 (5), (6), (7), (9) and (10)."

**Assessment:** Review the appropriate references in the FAC. See recommendation for new zoning district for mining (see Part 3, Issue 6)

#### Major Local Issues:

Issue 6- Preserve environmental resources

### Policy 1.04A.07B

"The County, within its ability to do under state law, shall prohibit any mining operations, which would negatively impact quality and quantity of groundwater supplies of existing users."

**Assessment:** Explore the creation of more specific and measurable criteria for this policy. See recommendation for new zoning district for mining (see Part 3, Issue 6)

### Major Local Issues:

Issue 6- Preserve environmental resources

### Policy 1.04A.07C

"Nassau County shall adopt LDRs that:1.define buffer zones around mining areas and resources which cannot be restored and restrict mining activities to land outside those buffers; 2.require identification and protection of archaeological properties on sites proposed for mining; and, 3.restrict the use of land that contains economically recoverable mineral deposits and lies outside environmentally sensitive areas to activities that will not preclude later extraction of those minerals."

 Assessment: Remove policy. The terms "strategic", "economically viable" and "environmentally sensitive" are too relative to provide acurrate criteria for mapping. See recommendation for new zoning district for mining (see Part 3, Issue 6)

### Major Local Issues:

# Objective 1.05

"Upon Plan adoption, the County will coordinate future land uses of the coastal areas to the ability to evacuate coastal areas in a major hurricane event."

Assessment: This Objective has been met, but needs to be updated or revised as follows:

- Remove timeframe
- Plan must incorporate new requirements of Ch. 163 (HB 1359), coordinate with Emergency Management.
- The objective should be revised to read as follows: "TheCounty will limit development in coastal areas based on its ability to maintain established evacuation times for a major hurricane event."

# **Major Local Issues:**

Issue 1- Update the future land use plan

### Policy 1.05.01

"The Nassau County Office of Emergency Management will coordinate with the Northeast Florida Regional Planning Council to maintain updates of the Northeast Florida Hurricane Evacuation Study, 1998, as it pertains to population versus evacuation times. The Office of Emergency Management will ensure that population projections and road conditions used to project evacuation times correspond to current conditions."

Assessment: This Policy has been implemented, but needs to be updated or revised as follows:

Update policy to reflect latest released Hurricane Evacuation Study (HES).

# Major Local Issues:

Issue 1- Update the future land use plan

### Policy 1.05.02

"The County Office of Emergency Management will maintain hurricane evacuation preparedness through simulation drills based upon "Clearance Times" for the County as defined in the Northeast Florida Hurricane Evacuation Study."

Assessment: This Policy has been implemented, but needs to be updated or revised as follows:

- Update policy to reflect latest released Hurricane Evacuation Study (HES).
- Plan must incorporate new requirements of Ch. 163 (HB 1359), coordinate with Emergency Management.

### Major Local Issues:

Issue 1- Update the future land use plan

# Objective 1.06

"Upon Plan adoption, the County shall implement the following policies in order to direct development into patterns, which will avoid the proliferation of urban sprawl."

Assessment: This Objective has been met, but needs to be updated or revised as follows:

- Refer to recommendations for Policy 1.02.05. regarding review of FLUM categories and encouraging efficient development patterns.
- See recommendations to policies linked to this objective below.
- The objective should be revised to read as follows: "The County shall direct development into patterns which will avoid the proliferation of urban sprawl."

#### Maior Local Issues:

Issue 1- Update the future land use plan

### Policy 1.06.01

"Ensure that development orders are conditioned on the concurrency with the provision of public facilities as identified in the plan."

**Assessment:** Efforts to implement this Policy are ongoing; new requirements of Ch. 163 (per SB 360) were incorporated into the CIE in 2007-2008. The LPA and staff will monitor future legislative mandates.

### Major Local Issues:

Issue 1- Update the future land use plan

### Policy 1.06.02

"Through interlocal agreements, the County shall strive to replace and/or consolidate public facilities and services in order to most efficiently establish and maintain established levels of service."

**Assessment:** Efforts to implement this Policy are ongoing; The County will continue to work with the municipalities of Callahan Hilliard and Fernandina Beach to assure consistent standards.

# Major Local Issues:

Issue 1- Update the future land use plan

# Policy 1.06.03

"Promote compact growth within urban development areas by encouraging the use of facility extension policies, whereby the cost of providing public facilities and services that benefit new development is borne by those individuals that receive direct benefit."

**Assessment:** This Policy has not been fully implemented. The following actions are recommended:

- Adopt LDRs that esablish criteria for facilities extension.
- Coordinate with municipalities and utility providers to establish urban service boundaries to guide development.

# Major Local Issues:

Issue 1- Update the future land use plan

### Policy 1.06.05

"Within 6 months of adopting the EAR based plan amendment, the County shall initiate a Special Area Study (also referred to as locally defined sector plan) of the Yulee Planning District. The Special Area Study shall include principals and guidelines that provide for the continued and improved coordination of land use with the transportation system. In addition, the Special Area Study will provide additional strategies for limiting urban sprawl and for advancing the efficient use of land and other resources. The Special Area Study will also evaluate the need to establish priority areas for development wherein a proposed development may receive special incentives such as density bonus-es. Other issues to be addressed by the Special Area Study will include the identification of regionally significant natural resources and a detailed identification and analysis of the distribution, extent and location of future land uses."

**Assessment:** This Policy has not been fully implemented ue to the abandonment of the Yulee Area-wide DRI. The following actions are recommended:

- Remove present policy. Discuss alternatives for an area-wide plan with appropriate public agencies and major landowners in the area.
- Discuss alternative transportation corridors to address capacity issues of AlA/SR 200.

### Major Local Issues:

Issue 1- Update the future land use plan

#### Policy 1.06.06

"The County shall discourage Urban Sprawl by requiring residential land uses to have minimum and maximum density ranges. As shown by the density ranges on the Future Land Use Map, This will allow higher density compact development to occur in areas served by public facilities and provide sound and more cost reliable public facility planning. It will also allow for lower density development to occur in areas that are environmentally sensitive or in areas that are not planned to receive a high level of public facilities or services."

**Assessment:** This Policy has not been fully implemented. The following actions are recommended:

 Refer to recommendations for Policy 1.02.05. regarding review of FLUM categories and encouraging efficient development patterns.

### Major Local Issues:

Issue 1- Update the future land use plan

# Objective 1.07

"Upon Plan adoption, the County shall implement policies to ensure that adequate land is available in the future to support components of infrastructure and public school facilities required for projected population growth."

Assessment: This Objective has been met, but needs to be updated or revised as follows:

Public school facilities will now be addressed in the PSFE (see Part 5).

#### **Major Local Issues:**

Issue 1- Update the future land use plan

### Objective 1.08

"The County shall develop innovative land development regulations, which assure that development is consistent with the future land use element."

**Assessment:** Efforts to meet this Objective are ongoing; no changes are required. Major review and revision of the land development regulations is required.

Issue 1- Update the future land use plan

# Policy 1.08.03

"The County shall include a landscape section in the Subdivision Regulations that will establish a level for using native vegetation in landscape design for future developments."

**Assessment:** This Policy has been implemented (not in subdivision regulations, however). Move policy to Conservation Element.

## **Major Local Issues:**

Issue 6- Preserve environmental resources

### Policy 1.08.05

"Review existing zoning ordinances and subdivision regulations and revise as necessary in order to implement the Future Land Use Plan."

**Assessment:** Efforts to implement this Policy are ongoing; the County should consider revisions regarding low impact development, rural/conservation subdivisions, and antiquated subdivisions.

### Major Local Issues:

Issue 1- Update the future land use plan

### Policy 1.08.06

"Review current ordinances, codes, and regulations and update code enforcement procedures to ensure compliance."

Assessment: Remove policy. Code enforcement policies do not need to be addressed in the Plan.

### Major Local Issues:

Issue 1- Update the future land use plan

### Policy 1.08.07

- Refer to recommendations for Policy 1.02.05. regarding review of FLUM categories and encouraging efficient development patterns.

Those land areas determined by the Board of County Commissioners with the advice of the St. Johns River Water Management District that are determined not to be jurisdictional wetlands will be allowed to be developed at the underlying land use densities and intensities."

# **Traffic Circulation Element**

# **Overview**

Like many Florida counties, Nassau County faces a number of transportation issues. The difficulty of linking long-term transportation planning goals with funding programs, as well as the recent decline in state and federal funding, has led to an increase in inadequate roadways to serve ongoing growth. According to the U.S. Bureau of the Census, 46% of the County's workforce commutes outside the county for work. This places a heavy strain on the County's road network during peak hours. The County maintains good working relationships with the Florida Department of Transportation (FDOT) and the First Coast Metropolitan Planning Organization (FCMPO). The County recognizes the significance of its future transportation needs and is exploring a number of options in terms of planning and funding needed improvements.

### Policy 2.01.02

"Backlogged Facilities. Backlogged are roads operating at a level of service below the minimum level of service standards, not programmed for construction in the first three years of the Five-Year Schedule of Capital Improvements, contained in the Capital Improvements Element, and not constrained. The list of roadway segments hereby designated as backlogged is as follows: I-95. The adopted level of service standard for roadways designated as backlogged shall be maintained. Any backlogged facility will be allowed to operate at levels that do not exceed a five percent increase in locally generated peak hour traffic volumes at the time of plan adoption added to the traffic volumes at the time of backlogged designation. Constrained Facilities. Constrained is defined as a road where a lane in each direction cannot be added due to physical or environmental conditions or policy. The list of roadway segments hereby designated as constrained is as follows:

- a. CR 105A from Gerbing Road to the Royal Amelia Golf Club entrance in Julia Street.
- b. SRA1A from Beach Lagoon Road to Amelia Island Parkway at the Ritz-Carlton Hotel intersection on SRAIA.
- c. Amelia Island Parkway from Julia Street to the intersection of CR105A.
- d. 14th Street from Lime to Atlantic Avenue.
- e. Scott Road from State Road 200/A1A to Amelia Island Parkway."

Assessment: This Policy has been implemented, but needs to be updated or revised as follows:

- Update LOS criteria per Sec. 163.3180 F.S.
- "Backlogged facilities" is no longer terminology in use with FDOT as it is written in this policy. Remove this section and reference to I-95, which is currently meeting LOS based on FDOT data.
- Confirm designation of constrained facilities.

# Policy 2.01.03

"In order to improve the level of service on I-95, Nassau County shall support and encourage FDOT to undertake activities aimed at removing the backlogged status from I-95."

# Policy 2.01.04

"Within 12 months of adoption of the EAR based amendments, update the island-wide transportation study (1986) to determine the proper LOS requirements on arterial and collector roadways."

- Remove policy
- Add new policy: "The County shall coordinate efforts with the FCMPO and FDOT to determine the proper LOS standards for arterial and collectors roadways throughout the County"

### Objective 2.02

"The County shall develop, construct, and maintain a major roadway network, which is consistent with the existing and future land use patterns."

Assessment: This Objective has not been met. The following actions are recommended:

- Coordinate with Baker Co. and Jacksonville to identify expansions of regional facilities.

The SR 200/A1A Access Management Overlay District provides a further means for the County to manage development along SR 200/A1A. The purpose of this district is to reduce traffic congestion. Development that takes place within this district will be managed with the aim of protecting the public investment in the existing transportation system and reducing the need for expensive remedial measures. In addition, the polices of this overlay district will further the orderly layout and use of land, protect community character and conserve natural resources by promoting well-designed road and access systems and discouraging the unplanned division of land. This district is shown in map form as part of the Future Land Use Map Series. It lies generally within 1000 feet of each side of SR 200/A1A and stretches from Edwards Road (which is one mile west of the I-95 and SR 200/A1A interchange) to the Intracoastal Waterway. In addition to the policies in 2.05.06 above, the following added policies shall also apply to development within this district:....(see Appendix F)"

Assessment: This Policy has been implemented, but needs to be updated or revised as follows:

- Review requirements for effectiveness, include FDOT comments in this analysis.
- Remove overlay or revise requirements as appropriate.
- Consider accress management criteria for other segments of the SIS.

# Policy 2.05.08

"The County shall request the FDOT PD&E study for SR 200/A1A to include an analysis of roadway capacity, alternatives to road widening such as frontage and parallel roads where feasible."

County staff shall provide data to update the model by maintaining a list of certificates of occupancy in a format that can be used by the model."

**Assessment:** Efforts to implement this Policy are ongoing; FDOT has updated the FSUTMS model. TAZ data and maps need to be included and expanded in the data and analysis.

- Study the feasibility of implementing the service options for providing new transit services as discussed in Section 10 of the Nassau County Transit Study, May 2000.
- 2. For service options that are feasible, the County will pursue federal and state grants to implement them.
- 3. Options that are to be considered for implementation, shall include, but not be limited to:
  - a. Develop a Rideshare/Park and Ride Program.
  - Develop a transit service to connect residential neighborhoods on Amelia Island with the various services and activities in Fernandina Beach and other areas of the Amelia Island.
  - c. Develop a Mainland transit service to connect the Yulee area with Fernandina Beach.
  - d. Study feasibility of parallel reliever roads to improve local road connectivity."

It may also be useful to public and private organizations that provide transportation services to persons with social needs and to the transportation disadvantaged."

Assessment: Reference is obsolete. Remove Policy.

# **Housing Element**

# **Overview**

The purpose of the Housing Element is to quantify housing needs and develop policies to ensure that a varied supply of housing types exists in Nassau County to meet the needs of residents. Such a variety of housing opportunities is critical to maintaining a heterogeneous population capable of supporting a well-functioning community. Because the County has historically functioned as a bedroom community of Jacksonville, single-family homes have been the dominant housing type. As housing costs have risen, the single-family home has increasingly become out of reach of a larger proportion of the population.

# Objective 3.01

"The County, during the period, 2000-2010 shall assist the private sector in the provision of affordable housing units to satisfy the demand of the existing and projected population, and of housing for special needs households."

**Assessment:** Efforts to meet this Objective are ongoing; no changes are required.

#### Major Local Issues:

Issue 7- Promote a greater diversity of housing types and prices

### Policy 3.01.01

"By 2003, Land Development Regulations shall provide a process including incentives which encourage the use of Planned Unit Developments (PUDs) and mixed use developments, and which will offer a variety of housing types. The LDRs shall include an affordable housing density bonus provision for planned development projects, allowing eligible affordable housing projects to receive up to a 20% density bonus based on the following table."

**Assessment:** This Policy has not been fully implemented. The following actions are recommended:

- Define and adopt bonuses and other incentives into LDRs as required by this policy.

### Policy 3.03.01

- Definitions and performance standards are required for greater specificity.
- Add internet/ website as resource for information

# Objective 3.06

"Within one year of EAR based plan amendment adoption, the County shall identify state, federal and private funding and technical assistance programs to preserve its historically significant housing. Implementation of these programs shall be ongoing through 2020."

- Revise timeframes
- Revise objective to read as follows: "The County shall identify state, federal and private funding and technical assistance programs to preserve its historically significant housing..."

Whenever these review times increase by 150% or more due to the work load of the review staff, the county will begin prioritizing the review of affordable housing development project applications. In prioritizing affordable housing development project applications, staff will schedule affordable housing project applications for review before other types of project applications to ensure that maximum review timeframes are not exceeded for affordable housing projects."

Assessment: This Policy has been implemented, but needs to be updated or revised as follows:

- Place under Objective 3.07.
- Establish performance criteria for inclusion as affordable housing development.
- Revise policy to read as follows: "The County shall strive to eliminate delays in the review of affordable housing development projects. In order to define delay, the county establishes the following maximum timeframes for approval of projects when an applicant provides needed information in a timely manner: Class I 5 days; Class II or III 5 weeks; Class IV 6 weeks; Special exception approval 8 weeks. If these review times increase by 150% or more due to the work load of the review staff, staff will schedule affordable housing project applications for review before other types of project applications to ensure that maximum review timeframes are not exceeded for affordable housing projects."

# Policy 3.08.07

# **Public Facilities Element**

# **Overview**

Chapter 163 of the Florida Statutes (F.S.) and Rule 9J-5 of the Florida Administrative Code (F.A.C.) provide the statutory authority for local government to establish a Public Facilities Element. The purpose of this Element is to provide for necessary public facilities and services based on existing and future land use and population projections. In Nassau County, public facilities are defined as sanitary sewer, solid waste, potable water, and stormwater management facilities. The element provides an inventory and analysis of the requirements placed on these facilities to meet the demands created by an increasing population.

# Objective 4.03

"Upon Plan adoption, the County shall regulate land use and discourage urban sprawl by adopting land development regulations that maximize use of current and planned infrastructure facilities."

Assessment: This Objective has not been fully met. The following actions are recommended:

- Refer to recommendations for Policy 1.02.05. regarding review of FLUM categories and encouraging efficient development patterns.
- The objective should be revised to read as follows: "The County shall regulate land use and discourage urban sprawl by adopting land development regulations that maximize use of existing and planned infrastructure facilities."

These recharge areas will be noted on a map series within the Comprhensive Plan so that requests for rezoning or land use changes in these areas can be evaluated both in terms of need and potential impact to the aquifer."

#### Policy 4.05A.02

"The County, in coordination with DEP and the St. Johns River Water Management District shall, under the SWIM program, identify all known point and non-point sources of pollution within the County. ### Policy 4.05B.06E

- County will integrate new LIDAR topographic data (available late 2008) into inventory and analysis

Administrator of the Federal Insurance Administration under the provisions of 44 CFR 65.12, as amended."

**Assessment:** This Policy has been implemented through the County's Floodplain Ordinance; revise as follows:

The policy should be revised to read as follows: "The County shall enforce the County's Floodplain Ordinance to regulate encroachments, including fill, new construction, substantial improvements, and other development, within a FEMA designated "special flood hazard area" that would result in any increase in flood levels during the occurrence of a flood discharge."

# Coastal Management Element

# **Overview**

The purpose of the Coastal Management Element is to identify the Coastal area, coastal resources, and the coastal infrastructure within Nassau County. The goal of this element is to guide the protection, conservation, and enhancement of the natural coastal environment, maintaining and enhancing access, maintaining compatible development and redevelopment of the area, and creation of appropriate emergency preparedness programs. Protection, conservation, and enhancement are to be achieved by protecting natural systems from development, undertaking necessary studies and actions to maintain the beach dune system and beach restoration activities, turtle monitoring activities, and monitoring activities of the ocean outfall.

To assure enhanced access, the element calls for exploring additional boat facilities, retaining existing recreational parking, retaining existing access and exploring partnerships with other organizations to enhance access. To assure compatible development and redevelopment, the element calls for protection of resources, establishing reasonable levels of service, establishing appropriate intensities of development, and enhancing access. Finally, to assure safety of individuals and property, the element calls for appropriate emergency preparedness, evacuation and disaster relief programs.

#### Objective 5.01

"The County will maintain, improve, and increase public beach access through acquisition and other land use controls."

**Assessment:** Efforts to meet this Objective are ongoing; no changes are required. ROSE includes LOS standards for beach accesses with parking.

#### Major Local Issues:

Issue 10- Create a first-class parks and recreation system

### Policy 5.01.01

"The County shall maintain inventory and analyze existing public beach access and demand to establish future beach access requirements based upon projected

populations. By 2005, a study of needs will be completed and the findings incorporated into the Recreation and Open Space and Coastal Management Elements through the Comprehensive Plan amendment process. In the interim, a LOS standard of the average of 1 beach access point per 10,000 persons shall be established."

**Assessment:** This Policy has not been fully implemented. The following actions are recommended:

- Remove policy
- Incorporate beach access requirements into proposed Recreation Master Plan (see recommendations for Objective 7.01).
- Recognize intergovernmental aspects of beach access in the County (w/ City of Fernandina Beach)

**Assessment:** Efforts to implement this Policy are ongoing; However, fewer opportunites will exist to implement this policy as coastal areas approach build-out.

### Policy 5.01.05

"Private land owners adjacent to public beach access points, including easements, will not be allowed to restrict public access to the beaches through access points."

### Policy 5.01.07

"By 2005, County in cooperation with FDEP will develop a beach access and parking plan that will assure maximum accessibility to public beaches while providing sufficient protection to maintain the current quality of the beach and dune system."

- Revise timeframe.
- Incorporate this requirement into proposed Recreation Master Plan (see recommendations for Objective 7.01).

# **Conservation Element**

## Overview

The purpose of the Conservation Element of the Nassau County Comprehensive Plan is to provide the framework for the preservation, protection and wise use of the County's natural resources. The intent of the element is to guide the decision-making process of local citizens, policy makers, appointed and elected officials for the appropriate use and conservation of natural resources in response to the growing urbanized area of the County. The protection and conservation of natural resources is of paramount importance in maintaining and improving the high quality of life that County residents demand. The Conservation Element contains goals, objectives and policies (GOPs) necessary for, or related to the protection and preservation of the County's natural environment and resources.

Stakeholders for the Conservation Element include a number of County, State, and Federal departments and agencies. The continued involvement of these entities, as well as local residents, business interests and non-governmental organizations will play an important role in assisting the County to achieve the objectives and policies as stated in the Conservation Element during the planning period.

### Objective 6.01

"Upon plan adoption, the County will ensure that it has adequate water supplies, of a quality sufficient for its intended use to meet existing and projected future demands by implementing the following policies."

Assessment: This Objective has been met, but needs to be updated or revised as follows:

See recommendations for policies linked to this objective below. Revise objective to read as follows: "The County will ensure that it has adequate water supplies, of a quality sufficient for its intended use to meet existing and projected future demands."

### **Major Local Issues:**

Issue 6- Preserve environmental resources

### Policy 6.01.01

"The County shall require, consistent with the rules of the SJRWMD, that wastewater be reused where practical. New wastewater treatment plants shall be required to provide for the reuse and/or disposal of wastewater by best available technology, including for agricultural or landscaping irrigation, percolation, or other permitted measures unless data are presented to support claims for the inability to support such reuse."

Assessment: Redundant policy; remove an refer to Public Facilities Policy 4.04.05.

"Within one year of adopting the EAR based plan amendment, the County shall request the City of Fernandina Beach and industry to jointly coordinate with the SJRWMD to determine the need for alternative water supplies to help meet future demands. "The County shall withhold development rights to future land development unless infrastructure (which includes water supply capacity and facilities) is available concurrent with the impacts of that development in accordance with 9J-5.0055(2) (a), (b) and (c). 1. The County will form a study group to coordinate with the State of Florida and the SJRWMD to uniformly collect and analyze water use data every two years to determine water use trends, including projections and water quality, to ensure adequate future water supplies for all reasonable and beneficial users."

- Water use trends and use projections should be incorporated into the SJRWMD Water Supply Plan
- Revise policy to read as follows: "The County shall withhold development permits unless water supply capacity and facilities are available concurrent with the impacts of that development in accordance with 9J-5.0055(2) (a), (b) and (c) F.A.C."

## Policy 6.01.06

"The County shall continue to enforce the Uniform Energy Conservation Construction Code that requires water conserving plumbing fixtures and devices in new construction."

- Review State energy efficiency ("green building") standards for possible inclusion.

All wetlands, as verified by jurisdictional field delineation at the time of project permitting, are designated as limited development overlays and shall be protected by policies contained within this Plan."

"Incompatible Land Uses are directed away from wetlands by the following mechanisms: 1.Residential densities in wetlands shall be as described by Policy 6.02.03g, above. 2.Clustering non-agricultural land uses away from wetlands is required. 3.Development shall first avoid wetland impacts and then minimize impacts when they are unavoidable."

**Assessment:** This Policy has not been fully implemented. The following actions are recommended:

Removal of invasive exotics vegetation shall not be considered as part of the overall mitigation ratio."

"Within one year of adopting the EAR based plan amendment, Nassau County shall adopt LDRs that: 1.define buffer zones around mining and borrow pit areas. The LDRs will also define and resources which cannot be restored and restrict mining and borrow pit activities to land outside those buffers; 2.require identification and protection of archaeological properties on sites proposed for mining/borrow pits; and, 3.restrict the use of land that contains economically recoverable mineral deposits and lies outside environmentally sensitive areas to activities that will not preclude later extraction of those minerals."

# **Recreation & Open Space Element**

### **Overview**

The purpose of The Recreation and Open Space Element (ROSE) is to inventory existing open space and recreational resources of the community, identify adopted standards and analyze the needs for future improvements. This goal requires resource allocation for high priority recreational opportunities and facilities, provision of additional recreational opportunities in new developments, and the retention of existing open space throughout the County. These goals are to be achieved through adoption of LOS standards, provision of additional facilities through SCI allocations, other funding sources and by the private sector as part of development. Priority is to be placed on retaining and enhancing large existing open spaces. Enhanced access to the Intracoastal and the beach are also encouraged.

The ROSE guides the County's capital program designed to meet the ever-increasing demand for parks, and open space necessary to serve new development and to maintain the quality of life enjoyed by existing residents.

County park levels of service (LOS) for concurrency management purposes are established in the Comprehensive Plan, Open Space Element and Recreation Element

and the Capital Improvement Element. Park LOS is calculated by comparing county-wide population to current inventories and then expressing the results in terms of total acres of parks available per 1000 population. However, he current LOS standard is skewed by the inclusion of State Parks in the calculations. This should be addressed in the update of the Plan.

# Objective 7.01

"Upon plan adoption, the County shall continue to adequately and efficiently develop and maintain the neighborhood and community recreation facilities listed in the plan through the year 2010."

**Assessment:** This Objective has been partially met, but needs to be updated or revised as follows:

- Create a County-wide Recreation Master Plan(see Issue 10 recommendations).
- Revise objective to read as follows: "The County shall efficiently develop and maintain adequate neighborhood and community recreation facilities through the creation of a Recreation Master Plan that will project recreational needs through the year 2030."

### **Major Local Issues:**

Issue 10- Create a first-class parks and recreation system

### Policy 7.01.01

"The County shall develop and maintain an inventory of county owned or operated parks and those available to county residents through interlocal agreements, by function of park (community, or regional) and a general inventory of recreation facilities. The County shall use this inventory as part of a detailed assessment of recreation needs. The methodology for this assessment is described in the Recreation Element Data and Analysis. The assessment shall be completed within two years of adoption of the EAR based plan amendment and shall be used as the basis for developing revised LOS for recreation and open space."

**Assessment:** This Policy has not been fully implemented. The following actions are recommended:

- Define regional park LOS as a function of the total county population.
- Incorporate municipal and school district facilities into the inventory if an interlocal agreement exists.
- Revise policy to read as follows: "The County shall develop and maintain an inventory of county owned or operated parks and those available to county residents through interlocal agreements, by function of park (community, or regional) and a general inventory of recreation facilities. The County shall use this inventory as part of a Recreation Master Plan."

### Major Local Issues:

Issue 10- Create a first-class parks and recreation system

#### Policy 7.01.02

"The County shall adopt the following Level of Service (LOS) standards for Regional and Community Parks. These interim standards shall be revised, as necessary, based on the recommendations of the recreation assessment described in Policy 7.01.01."

# Intergovernmental Coordination Element

# Overview

The goal of the Intergovernmental Coordination Element is to promote the enhancement of intergovernmental coordination with cities in Nassau County, neighboring counties, cities and regional and state agencies.

Nassau County maintains an extensive list of intergovernmental coordination activities to ensure that new and existing development activities preserve the quality of life for residents and an efficient use of resources are utilized to accommodate growth as guided by the Comprehensive Plan. The County's rate of growth and development places a great deal of pressure on the delivery of core public services and infrastructure to residents.

Effective intergovernmental coordination plays a crucial role in the County's overall approach to meeting existing and future challenges. However, intergovernmental coordination activities by their nature are ongoing, and formal or informal activities require qualified staff, support systems and processes for successful implementation.

Consistency with the regional and state plans is coordinated through formal agreements.

Consistency with the regional and state plans is coordinated through formal agreements with the Florida Department of Community Affairs (DCA) and the Northeast Florida

Regional Council (NEFRC). Nassau County is also a member of the First Coast Metropolitan Planning Organization (FCMPO) which focuses on regional transportation planning and implementation activities.

# Objective 8.01

"Upon Plan adoption, the County shall implement new interlocal coordination mechanisms or continue existing agreements with all adjacent local governments, regional and state government agencies, County School Board and public facility providers that share responsibility for land use development and urban development patterns."

"The final responsibility for site acquisition for public schools lies with the Nassau County School Board, in compliance with all applicable rules, standards, criteria, plans laws and ordinances."

# **Capital Improvements Element**

### Overview

The primary purpose of the Capital Improvements Element (CIE) is to assess and demonstrate the financial feasibility of the Nassau County Comprehensive Plan. The CIE has a critical role within the County's comprehensive planning process. Other Elements of the Comprehensive Plan are closely tied with the implementation of the capital improvement program and transportation and recreation facilities are incorporated into the CIE to maintain consistency with the Comprehensive Plan and to ensure a healthy fiscal environment for the County. The capital improvement process utilizes this framework to assist and schedule the required implementation and construction of capital facilities or improvements to existing facilities through the regular County budgeting process.

The CIE goals, objectives and policies were extensively amended in 2007 pursuant to County Ordinance 2007-38 (DCA 07-2). This element is the most recently amended and is most reflective of the current legislative requirements, local conditions, and fiscal limitations.

The CIE has a key relationship with the Future Land Use, Recreation and Open Space, and Transportation Elements through concurrency and land use requirements stipulated in state regulatory policy. This requirement states that facilities and services must be available at their adopted Level of Service (LOS) standard concurrent with the impacts of development. This mandates that decisions concerning the programming of capital improvements and land development are correlated with each other. The CIE is implemented by the County's Concurrency Management System (CMS) to ensure new development will have adequate infrastructure and that the adopted LOS standards will be maintained. The Current Five-Year Capital Improvements Schedule is included in Appendix G.

# Objective 9.01

"Capital improvements shall be provided to: correct existing deficiencies, accommodate desired future growth and replace worn-out or obsolete facilities as indicated in the Five-Year Schedule of Improvements. Capital improvements in the context of the Comprehensive Plan shall include the traffic circulation system, potable water, sewage, solid waste, drainage, and recreation and open space facilities."

Assessment: Efforts to meet this Objective are ongoing; no changes are required.

### Policy 9.01.02

"The County shall maintain and annually update the Five-Year Schedule of Capital Improvements detailing the expenditures necessary for each new or renovated public facility, ranked in a list of need priorities and then compared with estimated funds available."

- d. Priority D projects which are desirable, but can be safely deferred beyond the third year of the five year projection in the Schedule of Capital Improvements."

# Policy 9.03.02
