RESOLUTION NO. 2009 - 163

A RESOLUTION AUTHORIZING THE CLOSING, VACATING, AND ABANDONING OF THOSE CERTAIN RIGHTS OF WAY OR THE RENOUNCING AND DISCLAIMING OF ANY RIGHT OR INTEREST OF SAID NASSAU COUNTY, FLORIDA, AND THE PUBLIC IN SAID RIGHTS OF WAY ASSOCIATED WITH THE CLOSURE OF THE PUBLIC HIGHWAY-RAIL GRADE CROSSING AT HARTS ROAD.

WHEREAS, the Board of County Commissioners of Nassau County, Florida, conducted a public hearing at 7:00 PM on the 24th day of August 2009, in the Commission Chambers at the James S. Page Governmental Complex, located at 96135 Nassau Place, Yulee, Florida, pursuant to a notice duly published as provided by law for consideration by the Board of County Commissioners to close, vacate, and abandon and to renounce and disclaim the right of the public and the county in and to that portion of Harts Road lying within the CSX Right of Way, which area is more particularly described in Exhibit "A" attached hereto; and

WHEREAS, said abandonment is necessary for the Stipulation of Parties by and between the County, CSX Transportation and the Florida Department of Transportation regarding the closure of the highway rail grade crossing at Harts Road and the opening of the offsetting crossing which will be opened on William Burgess Boulevard; and

WHEREAS, this Board finds that the subject roadway lies wholly without the corporate limits of any municipality and that this Board is authorized to close said roadway by the authority stated in Section 336.09, <u>Florida Statutes</u>; and

WHEREAS, this Board has determined that due to the opening of William Burgess Boulevard with a highway rail grade crossing which will offset the Harts Road crossing, it is in the best interest of Nassau County and the public, that the Harts Road crossing and the

Fee \$44.00 #2 roadway lying within the CSX right of way at Harts Road be closed, vacated and abandoned and that the interest of Nassau County and the public be renounced and disclaimed therein.

NOW, THEREFORE, BE IT RESOLVED this <u>24th</u> day of <u>August</u>, 2009, by the Board of County Commissioners of Nassau County, Florida, in a meeting duly assembled that due to the opening of William Burgess Boulevard with a highway rail grade crossing which will offset the Harts Road crossing, the Harts Road highway rail grade crossing and the public roadway lying within the CSX right of way at Harts Road shall be closed, vacated and abandoned and that the interest of Nassau County and the public be renounced and disclaimed as if said roadways or alleyways had never been opened and used by the public.

BE IT FURTHER RESOLVED that the right and interest of Nassau County and the public in said roadway, which is fully described in Exhibit "A" attached hereto, shall be renounced and disclaimed, and any easement heretofore owned, held, claimed or used by or on behalf of the public therein shall be abrogated.

BE IT FURTHER RESOLVED that the Clerk of this Board shall cause to be published, within thirty (30) days after the adoption of this Resolution, in one issue of the Fernandina Beach News Leader, a notice of the adoption of this Resolution closing, vacating, and abandoning all of that portion of Harts Road, a public roadway, lying and being within the CSX right of way and renouncing and disclaiming of any right or interest of the county and the public in the subject right of way.

NOTICE IS HEREBY GIVEN that the Board of County Commissioners of Nassau County, Florida on the <u>24th</u> day of <u>August</u>, 2009 adopted a Resolution closing, vacating, and abandoning the segment of Harts Road at the Harts Road highway rail grade crossing and all the portion of

Hart's Rd lying and being within the CSX right of way, as more fully shown in Exhibit "A" attached hereto.




