## RESOLUTION 2010- 11

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY ACCEPTING AND ADOPTING FOR PLANNING PURPOSES THE POST DISASTER REDEVELOPMENT PLAN; PROVIDING FOR FINDINGS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Nassau County was selected as one of six pilot communities to receive funding through a grant from the Florida Department of Community Affairs, Divisions of Community Planning and Emergency Management for the purpose of creating a process and format for development of a Post Disaster Redevelopment Plan (PDRP); and

WHEREAS, PBS & J of Jacksonville, FL was the lead consultant working with the Executive Technical Committee, elected officials, staff and the general public to create the PDRP; and

WHEREAS, the PDRP links existing emergency management plans and the comprehensive plan; and

WHEREAS, Section 9J-5.012(3), F.A.C. requires each coastal jurisdiction to include in the Coastal Management Element of their comprehensive plan a PDRP; and

WHEREAS, the PDRP provides a guide for the transition from short term response to long term recovery and redevelopment; and

WHEREAS, the PDRP will enhance State and Federal disaster assistance, improve public input and facilitate the return of economic, community, social, governmental and environmental structures in the aftermath of a catastrophic event.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA:

## **SECTION 1**

The Board of County Commissioners does hereby accept and adopt for guidance during the recovery and redevelopment phase following a catastrophic event in

Nassau County the Post Disaster Redevelopment Plan developed by the Nassau County PDRP Executive Technical Committee dated September 2009.

## **SECTION 2**

The Board of County Commissioners finds that the Study satisfies the technical requirements of Chapter 163, F.S. and Rule 9J-5, F.A.C. and is suitable for adoption by reference into the Coastal Management Element of the 2030 Comprehensive Plan.

## **SECTION 3**

This Resolution shall become effective immediately upon its passage.
