

RESOLUTION NO. 2010- 147

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, HONORING ORRIN H. MAIN FOR HIS SERVICE TO THE CITIZENS OF NASSAU COUNTY, FLORIDA

WHEREAS, Orrin H. Main has been a long time resident of Nassau County, Florida; and

WHEREAS, Orrin H. Main was appointed to serve on the Nassau County Code Enforcement Board on March 8, 1999 as a charter member; and

WHEREAS, the Nassau County Code Enforcement Board, established pursuant to Ordinance No. 99-02 adopted on January 11, 1999, held its first meeting on June 22, 1999, at which Orrin H. Main was elected by his fellow board members to serve as Vice-Chairman and he later served as Chairman from August 8, 2000 until June 12, 2001; and

WHEREAS, Orrin H. Main continued to serve as a member of the Nassau County Code Enforcement Board until June 2008, when he tendered his resignation from the board; and

WHEREAS, pursuant to Rule 12D-9.004, Florida Administrative Code, Orrin H. Main was appointed to serve as a citizen member of the Nassau County Value Adjustment Board on July 28, 2008; and

WHEREAS, his service on the Nassau County Value Adjustment Board exemplified his compassion for his fellow citizen in hearing appeals related to the assessment of property; and

WHEREAS, Orrin H. Main has served the citizens of Nassau County through an equal and fair application of the laws governing Nassau County; and

WHEREAS, Orrin H. Main is commended for his many dedicated and long hours of service he performed in serving this community; and

WHEREAS, his diligence and fairness represents an extraordinary example for all who serve on appointed boards.

NOW, THEREFORE, BE IT RESOLVED this 27th day of September, 2010, by the Board of County Commissioners of Nassau County, Florida , that:

1. The Board of County Commissioners publicly commends and thanks Orrin H. Main for his nine years of service to the citizens of Nassau County, Florida as a member of the Nassau County Code Enforcement Board from 1999 to 2008 and for his two years as a member of the Nassau County Value Adjustment Board from July 28, 2008 to September 15, 2010.
2. The Board of County Commissioners commends and congratulates Orrin H. Main for his past work for the citizens of Nassau County and for his service to the community.


