NOTES OF REGULAR SESSION, OCTOBER 11, 2010

1. Approve Tabs A, B, C, D, F, G, H, I, and M.
2. Tab E - Approve Resolution 2010-156, updating Resolution No. 2006-151, as Amended, Financial Policies for the Board of County Commissioners, Providing an Effective Date, except for Section 1, Operating Budget Policies, 1.6, items B and C approving title changes (Administrator to Manager) only.
3. Tab J - Continue to a date in the future consideration of the following: (1) approve and authorize the Chairman to sign the Interlocal Agreement with the City of Fernandina Beach for fire protection and emergency medical services, (Contract No. CM1667); and (2) establish effective dates on the agreement.
4. Tab K - Continue to October 25, 2010 appointment of a representative for District 3 to the Conditional Use and Variance (CU&V) Board. (Under Commissioner's items Teresa Burch was re-appointed to the CU&V Board for District 3.)
5. Tab L - Continue to December 13, 2010 at 7:00 p.m. consideration of an Ordinance amending Ordinance No. 97-14, as Amended by 2005-22, Known as the Right Of Way Usage ordinance; Specifically Amending Section 4, Prohibited Acts; Section 5, Uses for Which Permits Shall Not Be Issued; Section 6, Permitted Uses; Section 7, Permit Procedures; Section 8, Appeal Process; Providing for an Effective Date.
6. Tab N - Schedule a public hearing for November 8, 2010 at 7:00 p.m. to amend Ordinance No. 89-10, as amended, known as the Public Nuisance Ordinance, to provide for definition of "Unserviceable Vehicles".
7. Commissioner Item - (1) Accept the Youth Basketball Program into the County utilizing the Yulee Sports Complex Gymnasium; (2) Upon submission to the Parks and Recreation Department (forward to the County Attorney) of the signed and authorized USSSA Program documents with proof of insurance with Nassau County Board of County Commissioners named insures and the required insurance amounts listed; and (3) Upon Submission of the signed County Agreement authorize

the Chairman to sign and authorize the agreement for the use of the gymnasium.

8. Commissioner Item - Approve to re-appoint Teresa Burch as District 3 representative on the CU&V Board.
9. Commissioner Item - Expend \$271.00 from District 4 Discretionary Fund payable to Sutton Place Behavioral Health, Inc. for material to build three new picnic tables at the Hilliard facility.
10. Commissioner Item - Expend \$200.00 from each of the five Districts Discretionary Fund (Totaling \$1,000.00) payable to the Amelia Island/Fernandina Beach/Yulee Chamber of Commerce for the Buy Local Program.
11. Commissioner Item - Approve placing \$300,000.00 each in Districts 3, 4, and 5 Level and Overlay Expense Accounts and designate \$600,000.00 (\$300,000.00 each from Districts 1 and 2) in a Reserve Account for the Fernandina Beach Library.
