## RESOLUTION NO. 2011-104 A

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF NASSAU COUNTY, FLORIDA, PURSUANT TO ORDINANCE NO. 2011-06, WHICH AUTHORIZES THE BOARD OF COUNTY COMMISSIONERS TO PASS BY RESOLUTION A FIREWORKS AND BURN BAN WITHIN THE UNINCORPORATED AREAS OF NASSAU COUNTY; AND PROVIDES FOR APPLICABILITY OF OPEN FIRES BAN TO SAID AREA; AND PROVIDES FOR A TERM OF THE BAN.

WHEREAS, Ordinance No. 2011-06, (hereinafter the Ordinance), adopted by the Board of County Commissioners of Nassau County, Florida on June 27, 2011, provides the authority for the enactment of this Resolution; and

WHEREAS, the Ordinance provides the authority for the Board of County Commissioners to enact a resolution to prohibit the use or discharge of any or all of the following items: (1) fireworks as defined in Section 791.01, Florida Statutes; (2) sparklers as approved by the Division of State Fire Marshal pursuant to Section 791.013, Florida Statutes, and any other sparklers; (3) flares; (4) any other outdoor burning such as lawn, debris and trash; and (5) campfires or outdoor burning, except those cooking fires in attended and monitored barbeque equipment; and

WHEREAS, the Interim Fire Chief has recommended to the County Manager, based on the drought index, that the Board ban any outdoor burning such as lawn, debris and trash; and campfires or outdoor burning, except those cooking fires in attended and monitored barbeque equipment; and

WHEREAS, the Board of County Commissioners of Nassau County, Florida, has declared that the duration of the ban on any other outdoor burning such as lawn, debris and trash; and campfires or outdoor burning, except those cooking fires in attended and monitored barbeque equipment shall commence on July 8, 2011 and continue through July 15, 2011.

NOW, THEREFORE, BE IT RESOLVED, this \_\_\_\_\_\_ day of July, 2011, pursuant to the authority granted by Nassau County Ordinance No. 2011-06, that:

1. The Board of County Commissioners of Nassau County, Florida, does hereby declare a burn ban for a period commencing July 8, 2011 and continuing through July 15, 2011.

2. The use of the following items is prohibited: (a) any other outdoor burning such as lawn, debris and trash; and (b) campfires or outdoor burning, except those cooking fires in attended and monitored barbeque equipment.

3. Said Resolution may be extended for a seven (7) day period by the Board of County Commissioners or by Proclamation of the Chairman of the Board of County Commissioners, or in his/her absence, the Vice Chairman.

4. The appropriate media shall be notified of the fireworks and burn ban as well as municipalities. Said notification shall be through the office of the Fire Chief.
